I demand all my rights that were established by, the Articles of Confederation (1781) and the Constitution for the republic of united states of America (1787), and all Government officials are my fiduciaries, and have an oath of office to protect my unalienable Rights. 68. 71. Neither the Transportation Code, nor the Uniform Commercial Code, nor the Internal Revenue Code are *positive law*, therefore, there is no authority whatsoever, to impose anything in any of them on me, and further,

72. Rep. 300 and further,

75. I can be a citizen of a state without being a US citizen; "*...that there was a citizenship of the United States and a citizenship of the states, which were distinct from each other, depending upon different characteristics and circumstances in the individual; that it was only privileges and immunities of the citizens of the United States that were placed by the amendment under the protection of the Federal Constitution, and that the privileges and immunities of a citizen of a state, whatever they might be, were not intended to have any additional protection by the paragraph in question, but they must rest for their security and protection where they have heretofore rested.*" Maxwell v Dow, 20 S.C.R. 448, at pg 451 "One may be a citizen of a State and yet not a citizen of the United States. Thomasson v State, 15 Ind. 449; Cory v Carter, 48 Ind. 327 (17 Am. R. 738); McCarthy v. Froelke, 63 Ind. 507; In Re Wehlitz, 16 Wis. 443. "McDonel v State, 90 Ind. Rep. 320 at pg 323; "Privileges and immunities clause of the Fourteenth Amendment protects only those rights peculiar to being a citizen of the federal government; it does not protect those rights which relate to state citizenship. 14, § 1. "Jones v Temmer, 829 F.Supp. 1226 (D.Colo. 1993); and further,

76. A US citizen is a "person", according to your (so-called) Fourteenth Amendment. The US Department of Justice admitted in My case # 07-5674, with the US Supreme Court that a US citizen is a Title 15 USC § 44 unincorporated corporation. A US citizen does not have any rights and is actually a piece of property. A slave is a slave because it is a piece of property and as such, a US citizen does not have any rights, and is also a slave. "*...the privileges and immunities of citizens of the United States do not necessarily include all the rights*

*protected by the first eight amendments to the Federal constitution against the powers of the Federal government." Maxwell v Dow, 20 S.C.R. 448, at pg 455;"The only absolute and unqualified right of a United States citizen is to residence within the territorial boundaries of the United States," US vs. Valentine 288 F. Supp. 957 and further,*

77. Title 26 USC (Internal Revenue Code) is not positive law and I have not agreed to be subject to any of the colorable codes, rules, and regulations found in Title 26 United States Code, which are all for government employees, and further,
78. I am not a government employee and i have never been a government employee, and further,
79. I am not a resident and I have never been a resident, and if you think i am or that i was ever it is and was a mistake, and further,
80. I am not a resident of the United States, and I have never been a resident of the United States, and further,
81. I am not a resident of the State of California, and I have never been a resident of the State of California, and further,
82. I am not a resident of the County of Orange, and I have never been a resident of the County of Orange, and further,
83. I am not a resident of the City of Huntington Beach, and I have never been a resident of the City of Huntington Beach, and further,
84. I do not have a Social Security Number, or any such "Taxpayer Identification Number", and I have never had a Social Security Number, or any such "Taxpayer Identification Number", and further,
85. My "proper mailing address pursuant to 18 USC § 1342", and "...unless you want to by guilty of mail fraud it shall be shown EXACTLY like on page 1.", and further,
86. "...I am not a second class UNITED STATES, 14<sup>TH</sup> Amendment citizen, corporation or other fictitious entity...", and further,
87. And if you think you have the authority for making a legal determination for me, you as a living private, man or woman, that thinks you "representing me", you are

NOW "FIRED!", and further,

88. "neither you, nor any other person, is competent for dealing with any of my affairs", and "i am competent for dealing in all my affairs", and further,
89. Title 18 USC § 242 makes it a felony to violate my rights under the *color of law*. 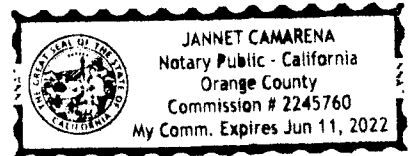
