Fall Campout Rules @ Highland County Fairgrounds

October 11th-October 13th

RV contained camping includes water and electric for the entire weekend for \$75.00 per site for those whose applications and payments are received on or before October 1st. No refunds after this date. Reservations received after this date will be charged \$100.00 per site.

There will be a costume parade with prizes & other activities during the weekend. Also, this year there will be a Quality Assurance program for Jr. Fair participants held on Sat. morning at 9 am. This program will be good for the 2020 season/ programs. Please pre-register with the Highland County's OSU Extension office, Kathy Bruynis, 937-393-1918 or bruynis.5@osu.edu.

Campers will be allowed to set up starting Thursday October 10th from 4pm to 8pm or Friday after 2pm. Campsite must be cleaned up and vacated by Sunday October 13th by 3pm.

Rules:

1. The person renting the campsite must be an adult residing at the campsite and be responsible for the behavior and welfare of all other members staying at the campsite.
2. NO outside refrigerators which are not part of the camper
3. Intoxication, profane, or vulgar language, excessive noise, or disorderly conduct of any type will not be tolerated. Any of these are sufficient reason for the eviction from camping areas and fairgrounds, without refund or unused fees.
4. Camping areas must be quieted by 12am-midnight CURFEW TIME and campers must be on their respective lots by then. Any person not observing the curfew time may be evicted.
5. One camping unit per lot (NO tents) No one is permitted to sleep in car.
6. Solid waste, garbage, cans, and paper is to be disposed of in trash barrels. Absolutely NO leaking gray or black water. Use DUMP STATION located next to red gate to dispose of black & gray water. Violators may be asked to leave and their camping fees forfeited.
7. No grilling, cooking, fire rings, or other sources of open flames are permitted under awnings or canopies. Fire rings must be self-contained and elevated. Camper must provide their own fire-ring. No trash to be placed in fire and ashes dumped in metal trash cans provided by HCAS.
8. Open fires in elevated rings are allowed, conditions permitting.
9. Failure to use assigned campsite or transfer of site without the permission of the HCAS's written approval WILL result in loss of camping privileges.
10. Units may be placed on assigned lots beginning at 4pm on Thursday. October 10th camping may commence after and run until Sunday October 28, 2018. No electric/water will be available before or after this time.
11. Bicycles are allowed on the campgrounds and fairgrounds. Golf carts/gators are permitted but must be driven responsibly by a person 18 or older with a valid driver's license. Motorized vehicles can only be driven on roadways and paved areas, violators may be asked to leave the camping event.
12. Camping locations to be determined by camping supervisor. When you arrive, enter at the Red Gate located off SR 73. Before you set up, please visit the camping supervisor to check in and receive your camping permit and itinerary. All campers are to use potable drinking water approved hoses at campsites.
