

2023 Tagging Procedure

1. All animals MUST be in possession by June 1st, 2023 (EXCEPTIONS Market Chickens and Market Rabbits). All market animals must be born on or after January 1st, 2023.
2. **Feeder Calves, Swine, Boer Goats, and Dairy Goat Exhibitors (Market Only)**- will come to the fairgrounds on the following days below to pick up all paperwork and tags. If you want to bring your animals to the fairgrounds to be tagged, you will be allowed too. If you choose to NOT bring your animals to Tag-In, make sure you get the paperwork and tags on the following days.
 - a. Dates tags and paperwork can be picked up:
 - i. June 2nd, 2023: 11:00AM-1:00PM
 - ii. County Wide Tag-In: June 3rd, 2023: 8:00AM-10:00AM
 - iii. June 5th, 2023: 5:00PM-7:00PM
3. **Lamb Exhibitors**- if you would like to participate in the Production Class, we will allow exhibitors and their animals on the fairgrounds to be weighed and tagged on June 3rd, 2023, from 8:00AM-10:00AM. If you are a Lamb exhibitor and are not planning on participating in the Production Class, you do not need to bring your lamb, you may just come and pick up tags and paperwork on the above dates (2A) to be sent back in by June 15th, 2023, if you want.
4. **Dairy Feeder Exhibitors**- must come to the fairgrounds on June 3rd, 2023, from 8:00AM-10:00AM, to have your animals tagged and verified that your animals are one of the following dairy breeds: Holstein, Brown Swiss, Ayrshire, Guernsey, Milking Shorthorn, and Jersey.
5. All paperwork and pictures must be turned back in no later than **Thursday, June 15, 2023 (NO EXCEPTIONS). THIS IS THE ONLY FOR EXHIBITORS THAT DID NOT BRING THEIR ANIMALS TO TAG-IN!**
6. **County Born and Bred Hogs**- the exhibitors should already have the tag-in sheet since the breeder was supposed to fill out and sign. Pictures and paperwork will need to be turned in no later than June 15, 2023, to the Jr Fair Coordinator.
7. Tags will be \$5, so please bring exact change.
8. The following are the 3 options you have in order to return your paperwork by June 15th, 2023.....
 - a. There is a mail drop at the Jr. Fair Board office that you can leave your paperwork.
 - b. Mail it to Highland County Jr Fair Board, Attention Kaley Fannin, PO Box 564, Hillsboro, OH 45133.
 - c. Email to highlandcojrfair@yahoo.com (make the Subject the market species and if you have more than one market species, do an email for each species. Families can be put together in one email.)
9. Everyone that does not bring their animals to the fairgrounds is required to tag their own animals!!
10. Pictures need to be of each side of the animal as well as a picture showing the tag in the left ear. Please make sure that the pictures are clear and not blurry!
11. Feeder calves will still need to the Pre-Conditioning papers (yellow). Pre-Conditioning must be done between July 1 and August 1. Paperwork is due by August 15th!
12. The following will be the places on the fairgrounds where tags/paperwork will be picked up or animals will be tagged:
 - a. Feeder Calves, Hogs, Boer Goats, Dairy Goats- Pickup tags and paperwork at the Jr Fair Board Office
 - b. Lambs- Pickup tags and paperwork and/or weigh for Production Class at the Main Arena and Small Hog Barn. - Watch for map and route to come in.
 - c. Dairy Feeders- Watch for map and directions to be posted.
 - d. Any animals being tagged- Watch for map and directions to be posted.

*****Chicken order forms still need to be turned in by June 1 with money so they can be ordered from the hatchery! *** Order forms with money can be mailed to the address on the form or dropped off at the Jr. Fair Board Office.**
