Competition Awards:

All awards will be determined by the judges.

- Divisional Awards will be given out for 1st, 2nd, and 3rd place for EACH division.
- Each team will receive score sheets after each awards ceremony. The score sheet used by the judges is the UCA score sheet for School Cheer and Game Day divisions

Jump & Tuck Competition:

- **A jump off and tuck off will be held for each division.** Awards will be given to the winners in each division. There is a \$5 entry fee per athlete for each of the Jump and Tuck Competitions. There is no limit to the number of athletes per team that may participate. Payment will be accepted the day of the competition at the registration table.
