**RULES:**

1. **Golf Carts**, Gator, Mule, Ranger, etc. No RZR or similar style UTV will be permitted entry or issued a permit.
2. You must have a campsite during the 2023 fair and only one golf cart per campsite is allowed.
3. The golf cart/UTV must have headlights if driving at night and manufactured standard exhaust. It is recommended you have a horn.
4. The driver on the golf cart must be 18 years of age with a valid driver's license.
5. All registrations for the use of golf cart/UTV must be completed by 8/1/2022.
6. The fee is \$250.00 to use a golf cart/UTV during the week of the fair, September 3RD -9TH. Please send a check made payable to "HCAS".
7. Golf carts/UTV will not be allowed in the midway.
8. There will be designated parking areas on the fairgrounds to park. (marked in GREEN on map)
9. The Highland County Agricultural Society directors and their security personnel will enforce all rules. If you violate the rules, your golf cart/UTV permit will be revoked. No warnings will be issued. You may also lose your camping privileges.
10. The golf cart/UTV sticker must always be displayed on the front of vehicle and visible.
11. The speed limit is 10 miles per hour.
12. The maximum number of persons that may ride a golf cart/UTV, depends on the number of seats available. One rider per seat.
13. The operation of a golf cart/UTV while under the influence of alcohol or drugs is prohibited.
14. Careless driving or behavior that endangers or would likely endanger any person will not be tolerated.
15. If you lose your permit sticker after it has been issued, there will be no replacement and the golf cart/UTV must be removed from fairgrounds.
16. Golf carts/UTV are to yield to all pedestrians and livestock. Approach livestock very cautiously.
17. Must bring to check-in to receive a permit for the week, check-in will be 9/2/2023 9:00-11:00 AM and 5:00-7:00 PM at the Red Gate.
18. Must only park in designated parking areas, and a map of parking will be provided at time of check-in.
19. Operating time is 5:00 AM – 12:00 PM you can access the loop of fairgrounds. (marked in YELLOW on map)
20. Limited operating time is 12:00 PM-12:00 AM and from designated parking area to designated parking area only. (marked in RED on map)
21. Golf carts/UTV may operate in designated campground areas from 5:00 AM-12:00 AM daily.
22. If your UTV is denied a permit, you will be issued a refund.
23. Golf carts and UTV's must provide proof of insurance (\$250,000 Liability), insurance and campsite registration must be in the same name.
24. Golf carts/UTV are not permitted to exit fairground gates at any time, this includes car/trailer parking lots.
