

MAINTENANCE & POOL COMMITTEE

As fall approaches, we want to express our gratitude to everyone who visited the pool and Village Center amenities this season. The pool provided a refreshing refuge from the exceptionally hot summer weather.

We would like to extend our appreciation to the community members who volunteered their time to maintain the pool, tennis, and basketball courts, keeping them tidy and beautiful.

The Village Center restrooms and vending will remain open until approximately January 1st, 2025.

We have some exciting news to share: we are making improvements! The non-functional splash pad will be removed to create additional lounge and grilling space, improving the overall area.

In order to enhance the pool experience, the large pine trees along Creekside Drive and the pool fence have been removed. This will prevent pine needles from clogging the pool pump system and allow more sunlight to reach the pool water. Additionally, it will provide a better view of the sunsets. We are also working on landscaping plans to ensure privacy in the pool area. Furthermore, the old white PVC fencing is being replaced by a higher 6-foot black aluminum fence, which not only adheres to community standards but also reduces our liability. This exterior facelift will be a welcome sight.

YARD WASTE COLLECTION

October 9, 2024 (One Day Only)

Acceptable yard wastes for collections:

- Tree branches up to 5 inches in diameter and 8 feet in length
- Twigs or other woody sticks
- Cut hedges/bushes with woody stems
- Roots smaller than the diameter of your recycling container (FREE of DIRT)
- Soft, green hedge trimmings
- Garden residues including weeds, flowers, plants
- Tall, ornamental grasses

STRICTLY PROHIBITED:

- Regular grass clippings
- Edging (clumps of grass & dirt)
- Poisonous plants
- Stumps/logs
- Nuts/fruit from trees or plants
- Dirt on roots
- Wooden, plastic or metal garden stakes
- Plastic flower/plant containers
- Animal excrement
- Garbage or other foreign materials
- NO materials in bags or containers!

LEAF COLLECTION

- Leaves ONLY
- Last full week in October through the first week in December




Village Center Trees

The decision to take down the evergreen trees next to the pool was made after careful consideration and in response to ongoing issues caused by the trees. They were consistently disrupting the pool pump and filtration system, leading to significant maintenance challenges, especially following storms.

In the long run, removing these trees will provide a cost benefit to our community by reducing the frequency and extent of maintenance required for the pool. This proactive approach aims to ensure a more efficient and cost-effective operation of our pool facilities.

We are committed to enhancing the aesthetics and functionality of the pool area and will be implementing new landscaping to replace the removed trees. This new plan is designed to maintain the visual appeal of the area while mitigating the issues previously caused by the trees.
