Unapproved Patio Changes at 14 Oak Knoll: In accordance with the board's instructions, an additional \$50.00 fine will be issued to the homeowner at 14 Oak Knoll for unapproved patio modifications and failure to submit an architectural request. This fine will be applied monthly until the homeowner contacts EAM to address compliance, submits the necessary request, and arranges a payment plan via Axela for any outstanding association dues.
