

ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE MODIFYING THE FEE COLLECTED UPON FILING AN APPLICATION FOR PUBLIC OFFICE

WHEREAS, the governing body of the Town of Superior has reviewed Section 1-8-12 of the Superior Town Code and has found that the fee imposed by said Section does not adequately cover the costs associated with the processing of the application for running for public office; and

WHEREAS, the governing body of the Town of Superior desires to replace the existing Section 1-8-12 with a new Section 1-8-12 of the Town Code of the Town of Superior.

NOW, THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF SUPERIOR, WYOMING that Section 1-8-12 of the Superior Town Code is hereby revised in its entirety in the manner attached hereto, and by this reference, incorporated herein.

SECTION 1: Ratification. The above provisions are hereby ratified and affirmed.

SECTION 2: Authority. This Ordinance is adopted pursuant to the authority found in Wyoming Statutes Annotated, Section 15-1-103(a)(v) and (viii) (Lexis 2009).

SECTION 3: Short Title. This Ordinance Shall be known, cited and referred to as Nomination Application: Filing Fee, Section 1-8-12 of the Town Code of the Town of Superior.

*New Section 1-8-12 of the Superior Town Code*

1-8-12:     **NOMINATION APPLICATION, FILING FEE:**     Wyoming Statutes, Section 22-23-302 (Lexis 2009), as it applies to the Town of Superior, is hereby amended to read as follows:

“Not more than sixty (60) days nor less than forty (40) days preceding the town election, each candidate for a town office shall pay a filing fee of ten dollars (\$25.00) and sign and file with the town clerk-treasurer an application in substantially the following form:
