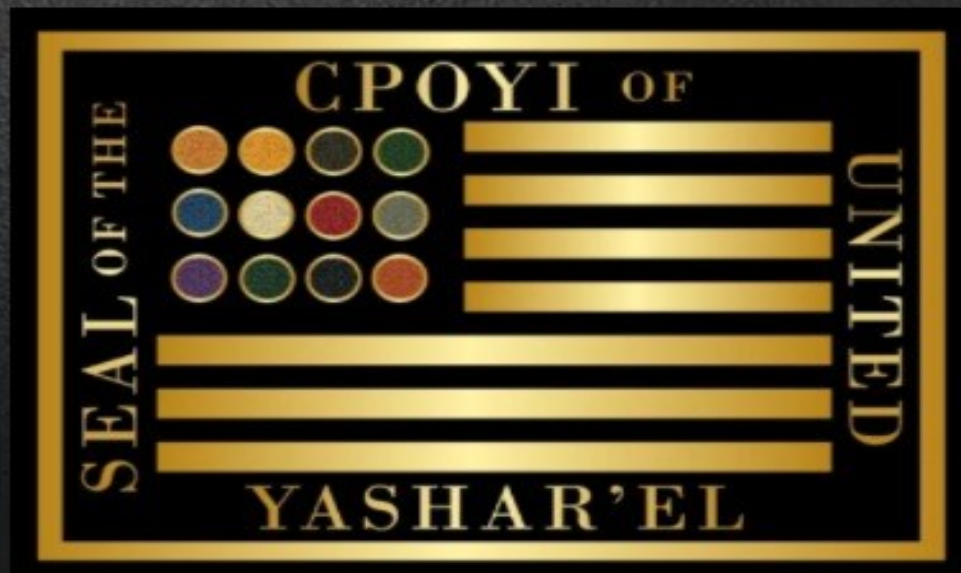
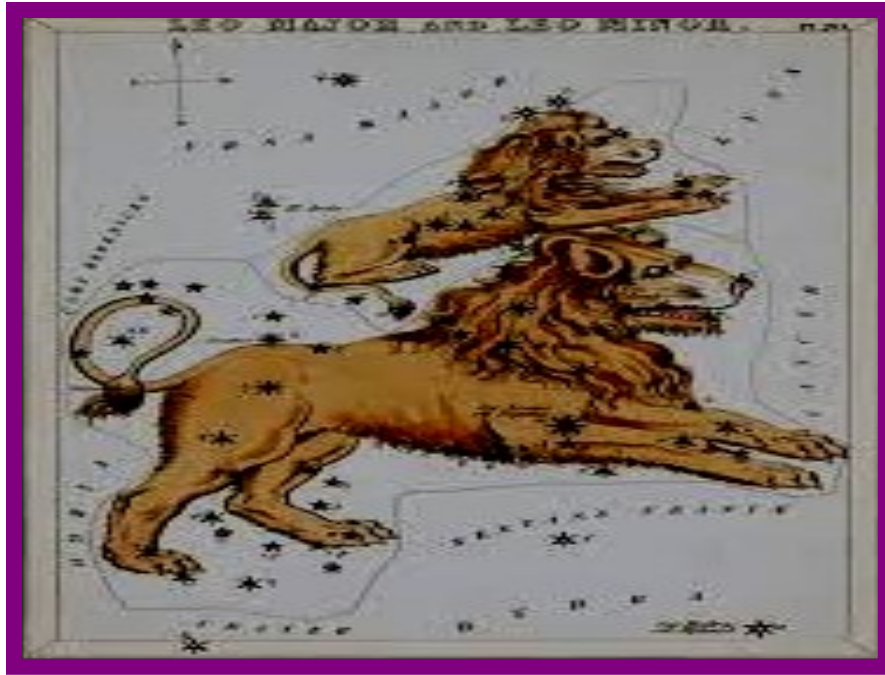

This Constitution may be cited as the Constitution of Judah, Israel

During his speech at the 400th anniversary of the Jamestown, Virginia assembly, the then - 45th President Donald J. Trump noted that 1619 was the first year enslaved Africans arrived to the English colonies in North America. He said, *"We remember every sacred soul who suffered the horrors of slavery and the anguish of bondage"*.

As the leader of the Free World and the premier voice of the western nations who participated in the Transatlantic Slave Trade, President Trump made a declaration, now documented, that ushered in the 2020's Global Lockdown and current political and economic realities: JUDGMENT ON THE WORLD NATIONS for not protecting the spiritual, civil, political, social, mental-health, economic, cultural and ethnic rights of the Children of Yashar'EL in the diaspora.

While President Trump's impact of the immutable Genesis 15:13-15 prophecy is debated, the public words of the U.S. President, in the realm of biblical narrative, like the announcements of the Pharaoh from ancient Kemet-Egypt, generate spiritual power, especially when spoken from the "bully pulpit". On January 6, 2023, His Royal Highness CPOYI Mikell submitted the Royal Decree of Withdrawal notification from the United States and the United Nations communities to the International Court of Justice (ICJ), the U.S. Department of Justice, the U.S. Congressional Black Caucus and the U.S. Senate.

The official process of withdrawal from the United States of America begins on October 16, 2025. The Royal House of Yehudah is an independent population, free from control by any other entity. This is our Constitution.

The time and labor involved in re-presenting the original codified Laws and Statutes of the United Kingdom of Yashar'EL in 2025 is the custodial duty of the Chief Principal of the House of Yehudah. Extending from the 16th—21st centuries, males and females born into the House of Yehudah have served a concurrent (individual) and consecutive (400 years) sentence. The statute that specifies the term of imprisonment and release is set forth in the Written Law, also known as the Torah and the Law of Moses [Genesis 15: 12-14 and Deuteronomy 28:15-68].

Many scholars of Ashkenazi Israeli and American law have determined U.S. law to be built on a notion of rights and the law of Yashar'EL on obligations and responsibilities. As the Crown Prince of Yehudah, I proudly take an oath to uphold and obey the Laws, Statutes, and Commandments of the Most High Elohim YAHAWAH and His Only Begotten Son, Christ Emperor King Yashiah.

The Torah is the foundation of all laws and regulations of the United Kingdom of Yashar'EL. These are different from the laws of the U.S. legal system. Whether or not international institutions, public or private, take an oath of allegiance to Christ Emperor King Yashiah now, or upon His return, the citizens of the United Kingdom of Yashar'EL all have an immediate duty to become familiar with the Code of Mosaic Law, the fundamental source of legal authority for the Yashar'ELites.

The representation of the United Kingdom of Yashar'EL in relation with the U.S. government and other subjects of international law, in diplomatic relations and business affairs is reserved for His Royal Highness CPOYI Mikell, who exercises sovereign power entrusted to him through the Office of CPOYI.

The Royal House of Yehudah Constitution was crafted by the office of CPOYI and holds significant legal and national security importance. It encompasses laws, commandments, ethical teachings and future forecast narratives. Beyond a simple legal code, our constitution provides the guidance, divine instruction and prophecy that will enable Yashar'Elites and allies to successfully navigate an unstable global economy in the midst of weak leadership characterized by greed, poor decision making and lack of integrity. Our constitution embodies a vital link in the Most High YAHAWAH's unbroken chain of governing law from time immemorial, the present and to the glorious future that lies in the soon-to-appear Millennial Kingdom. As the old Western order falls, part of my oath of office is to "promote Torah, establish national independence, and like John the Baptist, prepare the way for Christ Emperor King Yashiah." An informed citizenry is vital to our success as a nation.

Preamble

We, the Yashar'Elites, People of the Divine Covenant, and the Gentile elect from every tribe, nation, and tongue, in order to preserve our sovereign dignity, achieve Torah mastery, maintain a desirable measure of social service and the blessings of prosperity, hereby WORSHIP with courage, humility, gratitude and love, the Supreme name of the Most High YAHAWAH, the SOVEREIGN HOLY ONE, and with undivided Mind, Heart, and Body, Praise and Honor, do Serve HIS Only Begotten Son, YASHIAH, the Creator of all things seen and unseen, who has received all power and authority in the Multiverse and on Earth. It is through Christ Emperor King YASHIAH's dominion in Heaven and on Earth, past, present, and future, that We, the Elect sons of Abraham, Isaac, Jacob and King David, the legacy generation of the Christ Champion Congress of Royal Princes (C.C. CORP) do ordain and establish this Constitution of Yashar'EL.

Article I. DIVINE MANDATE

The Royal House of Yehudah reaffirms its sovereignty and recognizes its historical relationship with the United States of America. With the written Divine Mandate of our Monarch, His Majesty Christ Emperor King Yashiah, the ability for any horrifically pervasive evil Principality, Throne, Power, or Psalm 83 vassal state to define our identity, control our education, domestic and or foreign affairs is no longer legal.

If any court, government agency, official or private military and security company, cyber criminal including AI models, intends to organize and conduct activities that are threatening, deceitful and/or engineered to cause widespread harm towards the citizens of the United Kingdom of Yashar'EL, we, the Office of the CPOYI urge you to cease-and-desist from such acts.

Article II. IRREVOCABLE LIFE COVENANT PROTECTION AND TRIBAL SOVEREIGNTY

The legacy of Western colonialism, human trafficking, domestic terrorism and the global collaboration to produce disinformation as a mechanism to control the life "narrative" of the descendants of Yashar'EL in the United States of America and abroad, in both their internal and external affairs, is now restricted.

- (1). U.S. Federal law has reaffirmed that American Indians are not considered a racial or ethnic minority, but retain a unique status as a sovereign people.
- (2). Despite the eyewitness error of British government, mistaking the identity of the Khazar-Zionist-Israelis, The Balfour Treaty of 1917 proves the DNA descendants of Ibrahim, Isaac, and Jacob are a distinct "people."
- (3). In 2024 the UN General Assembly voted to upgrade Palestine's "non-member observer state" status and recommended the Security Council reconsider its bid for full membership. A U.S. veto denied this upgrade.
- (4). In the Vatican on April 12, 2013, Pope Francis declared to the members of the Pontifical Biblical Commission, "the Holy Bible is the testimony in written to the word of YAHAWAH". In other words, Hebrew Scripture witnesses to a WORD that is before and beyond the Torah, Prophets and Testaments.

Jeremiah 33:17 For thus says the Most High YAHAWAH; "King David shall always have an heir to sit upon the throne of the United Kingdom of Yashar'EL".

HRH CPOYI Mikell is the regent, the descendant of David who governs Yashar'EL until His Majesty the CHRIST and EMPEROR, KING YASHIAH, the rightful ruler of Yashar'EL and the world nations, returns.

NOW, THEREFORE, I, MIKELL, the Crown Prince of Yehudah, Yashar'EL have, by the rights and powers of the Most High YAHAWAH's Prerogatives and His Majesty Christ Emperor King Yashiah's Absolute Monarchy, do HEREBY PROCLAIM in King Yashiah's name and on OUR behalf and on behalf of OUR descendants as hereinafter follows: The Special Perpetual Sovereign status of Yehudah and the United Kingdom of Yashar'EL.

We are not a universally owned people. Our lives are not public domain. We are a Covenant People, with a High Priest and King in Yashiah and an Elohim, Abba YAHAWAH, who is SUPREME to all other elohim.

THEREFORE, in no way, shape, or form, either spiritually, psychologically, emotionally, nor physically, are we subject to the elohim-gods of this world system. Faith-determination is YAHAWAH's Kingdom government policy codified in TORAH by Moses. Our relationship with world governments, corporations, media, court systems as well as with law enforcement, will be modified to work on the side of justice.

Neither U.S. congressional legislation nor recognition from the United Nations is required to establish this emergency, transitional, interim government. Beginning with our reality here in North America, the Royal House of Yehudah/Judah, the sons and daughters of Yehudah, have been in a period of crisis for centuries. The birth pangs of YAHAWAH's judgment are already underway so this is not an act of revolution. Rather, the Office of the CPOYI aims to restore community order and prepare for a new, permanent government to be formed by Christ Emperor King Yashiah Himself.

Yashar'ELites worldwide are citizens of two sovereign entities: the United Kingdom of Yashar'EL, and the nation in which they reside. As a result of this unique status, we have the responsibility to re-establish our Covenant culture through a privately-funded education system for both youth and adults while utilizing Faith-determination to control our own economy.

Despite their display of regal and priestly character, both adult and youth Civil Rights activists of the American South were subjected to more strict class divisions within America's "Integration" system. Over the years, member states of the United Nations have shown hostility towards Yashar'ELites on their soil. As so-called "Blacks" in the U.S. increasingly sought to acquire the "American Dream", diverse people groups within the U.S. were provoked to violence utilizing both soft and hard power tactics.

After 11:59 PM on October 16, 2025, any unethical, harmful, immoral or unlawful executive orders, policies, socio-military experiments, propaganda campaigns or global initiatives implemented against the Yashar'EL diaspora will be classified as terrorism. World governments have an obligation to protect their citizens and the Office of CPOYI has the right and authority to activate the Ministry of Defense judgments necessary for Yashar'Elite survival. We call on the Sovereign, Just, and Holy Most High YAHAWAH to take firm, bold and concerted measures of multi-dimensional vengeance against both Spirit and Material enemies of Yashar'EL.

As the provisional government of the United Kingdom of Yashar'EL, the Office of CPOYI will partner with the House of Yehudah's energetic, Covenant-adhering leaders to rebuild our nation of Kings and Priests. As a people "chosen" by the Most High YAHAWAH and recruited by Christ Emperor King Yashiah to both rule and serve in His Millennial Kingdom, Yashar'Elite men and women, male and female, teenagers, boys and girls must be committed to accountability and spiritual reform from the top down. Torah-Law is essential.

Article III. TEN COMMANDMENTS FOR SELF-GOVERNMENT

It is a well-known axiom that the law of a nation should be studied through the looking-glass of its national life.

The Most High YAHAWAH reveals His word unto Jacob, HIS statutes and His judgments unto Yashar'EL. The Sovereign and Holy YAHAWAH has not dealt personally with any other nation: and as for HIS judgments, the other nations have not known them. All Praises to the Most High YAHAWAH. **PSALM 147:19-20**

AND WHEREAS WE have, with the record of the Covenant Law and history of OUR Yashar'ELite ancestors, decided to govern our lives by TORAH, in accordance with two ratified amendments, legislated in 33AD which make animal sacrifice an inoperative practice.

HIS MAJESTY'S Forgiveness Reform and Debt Discharge Amendment received Royal Assent on April 3, 33 AD corresponding to Nisan 14 in 33 AD.

Dated in the first millennium BCE, the Covenant as recorded in the TORAH of the United Kingdom of Yashar'EL includes references of the exodus from Kemet-Egypt in northeast Africa. This ancient covenant between a DIVINE SOVEREIGN and His people, clearly states the identity and authority of the sovereign.

Henotheistic monolatry, is the acknowledgment that other elohim-gods-angels exist. The Covenant given to the Yashar'Elites prohibits them from worshipping any of the elohim ruling the world nations. This is not a contract between peers. THEREFORE, the JUST and HOLY YAHAWAH has the right to dictate the terms.

The SOVEREIGN YAHAWAH said to Moses, "I hereby make a covenant. Before all your people I will perform marvels, such as have not been done in all the earth or in any nation, and all the people among whom you live shall see the work of the Lord, for it is an awesome thing that I will do with you." [EXODUS 34:10]

Statute 1. "I am YAHAWAH the Elohim of your forefathers Ibrahim, Isaac, and Jacob-Yashar'EL, I brought you out of Kemet-Egypt, out of the condition of slavery. You shall have no other gods before me."

Statute 2. "You shall not make for yourself an image in the form of anything in heaven above or on the earth beneath or in the waters below. You shall not bow down to them or worship them; for I, YAHAWAH your Elohim, require absolute loyalty from my beloved nation of sons and daughters, punishing the children for the sin of the parents to the third and fourth generation of those who hate me, but showing love to a thousand generations of those who love me by living inside the legal framework of my creation."

"Observe what I command you today. See, I will drive out before you the Adversary and the Serpent, the Dragon and the Whore of Babylon, the Nephilim, Witches, Sorcerers, Esau, Technocrats, Demons, and the Psalm 83 coalition. Take care not to make a covenant with the inhabitants of the continents to which you are going, or it will become a snare among you."

Statute 3. "You shall not improperly use the authority or influence that comes with the name of the Most High Holy YAHAWAH, for this will lead to unjust and harmful actions against others. YAHAWAH will not hold anyone guiltless. Every soul is accountable. When you violate trust in HIS name, whether in a personal or in an official capacity, causing various forms of corruption, bribery, coercion, lewdness, idolatry, perversion, and other forms of unrighteousness to manifest, the perpetrators will be subject to an appropriate measure of punishment."

Statute 4. “Remember the Sabbath day by keeping it holy. Six days you shall labor and do all your work, but the seventh day is a Sabbath to YAHAWAH your Elohim. On it you shall not do any work, neither you, nor your son or daughter, nor your male or female servant, nor your animals, nor any foreigner residing in your towns. For in six days YASHIAH made the heavens and the earth, the sea, and all that is in them, but HE rested on the seventh day. Therefore, our ABBA YAHAWAH blessed the Sabbath day and made it holy.”

Statute 5. “Honor your father and your mother, so that you may live long in the land the Lord your God is giving you.”

Statute 6. “You shall not murder. You have heard that it was said, 'You shall love your neighbor and hate your enemy.' But I say to you, Love your enemies and pray for those who persecute you. Whoever hates his brother is a murderer, and you know that no murderer has eternal life remaining in him. Beloved, never avenge yourselves, but leave the way open for the ALMIGHTY YAHAWAH’s wrath and HIS judicial righteousness; for it is written, ‘Vengeance is Mine, I will repay,’ says the Christ Emperor King YASHIAH.”

Murder is the commission of an unlawful act. For since death came through a Melanated Man, and not a man, woman, or child with low concentrations of a pigment responsible for color, the resurrection of the dead comes also through a Melanated Man. For as in Adam all die, so in Christ Yashiah all will be made alive.

But each in his own turn: Christ Yashiah the first fruits; then at HIS return to Earth, [post 2nd Exodus], those who belong to Him. He will reign over the world nations for one thousand years and, after having destroyed all dominion, authority, and power of the wicked world rulers of this world, the end will come. For Christ Emperor King Yashiah must reign until all His enemies are subdued. The last enemy to be destroyed is death. In His exemplary act of loyalty and honor, the ONLY BEGOTTEN SON, YASHIAH, will transfer all power of the kingdom to His Father YAHAWAH. In this transition, even the ONLY BEGOTTEN SON HIMSELF will be SUBJECT to Him who put all things under Him, so that the MOST HOLY SOVEREIGN YAHAWAH may be all in all. FOREVER.

Statute 7. “You shall not commit adultery.”

Christ Yashiah states, "But I say to you that everyone who looks at a woman with lustful intent has already committed adultery with her in his heart." The statement emphasizes that the sin begins in the heart and the mind. A person who willfully harbors lustful thoughts has already committed adultery in their heart, even if the physical act hasn't occurred. Lust often involves objectifying another person, seeing them as a means to one's own satisfaction rather than as a person with inherent dignity. While the scripture equates the sinfulness of lust with that of adultery, it does not mean the two are identical actions.

Statute 8. “You shall not steal.”

Crime committed by business, government, and religious professionals is identified as “White Collar”. These crimes are non-violent, but cause significant monetary damage instead of physical harm. The right of trial by jury shall remain inviolate, and the United Kingdom of Yashar’EL shall not deprive any Yashar’Elite or Gentile of life, liberty or property without due process of law, nor shall private property be taken for public

use without just compensation.

The judicial process of the United Kingdom of Yashar'EL shall be open to every person and entity within the jurisdiction of Christ Emperor King Yashiah. Speedy and certain remedy, and equal protection, shall be afforded under the laws of the United Kingdom of Yashar'EL.

Common types of white collar crime include: Theocratic fraud, Government fraud, Corporate Fraud, Bank Fraud, Intellectual property theft/piracy, Money laundering, Identity theft, Healthcare Fraud, Bribery.

Blue Collar Crime, also called "Street Crime," is often thought to be committed by youth and adults outside of "Professional" settings. These crimes often involve weapons and violence; however, they don't have to. There is generally an easily identifiable victim in street crime offenses.

There are generally two types of street crimes – crimes against persons and crimes against property.

Some crimes against other people include: Child support gouging, Unfair divorce settlements, School Shootings, Fake News, Police Brutality, Sexual assault, Domestic violence and deliberate STI/STD infecting.

Some common crimes against property include: Carjacking, Personal property theft, Motor vehicle theft, Burglary, Shoplifting, Arson, Vandalism, Trespass.

Statute 9. "You shall not give false testimony against your neighbor."

Perjury means to knowingly make a false statement under oath knowingly, or to sign a legal document known to be false or to contain false statements. The false statement must also be related to a material fact. That is, it can affect the course or outcome of the proceeding. Giving false testimony in the pulpit is a HIGH CRIME. A false witness is detestable to the Most High YAHAWAH. This includes minor falsehoods. More serious than small lies, false teaching involves misleading a congregation with unbiblical or heretical ideas. In his day, the prophet Jeremiah rebuked the "Chosen" people's religious leaders, Yashar'Elites, who "fill people with false hopes." In accordance with Covenant Law, all Yashar'Elite priests, prophets and ministers lying for a living will be disqualified and punished.

Statute 10. "You shall not covet your neighbor's house. You shall not covet your neighbor's wife, or his male or female servant, his ox or donkey, or anything that belongs to your neighbor."

Some common and legal definitions of Covet: The act of coveting is inherently wrong or unlawful. It's not just a simple wish, but a desire that goes against established rights or laws. The desire is excessive or inappropriate. It is an inordinate craving for something rather than a healthy wish for something that is rightfully attainable. The defining characteristic of coveting is the desire for something that rightfully belongs to someone else. Stealing land can be called larceny, theft or, more broadly, usurpation. To displace natives from their homelands is categorically the breaking of Statutes 10, 8 and 6.

During a national crisis of Yashar'EL, the Yehudah Constitution shall have and affirm the following rights:

The judicial process of Yashar'EL shall be open to every person within the jurisdiction of the CPOYI. Speedy and certain remedy, and equal protection, shall be afforded under the laws of His Majesty Yashiah.

Article IV. THE ROYAL RIGHTS AND LIBERTIES OF YASHAR'EL

“For the Only Begotten Son Yashiah, who holds preeminence over all creation, is the visible image of the invisible SOVEREIGN YAHAWAH. For in Yashiah all things were created; things in Heaven and on Earth, visible and invisible, whether thrones or powers or rulers or authorities in the unseen realms. The physical world of atomic and molecular structures, as well as the immaterial realm consisting of non-physical entities such as energy. Soul, consciousness and abstract concepts was created through Him and for Him”.

-Colossians 1:15-17 *Royal Translation*

According to sacred Hebrew teachings, Yashiah created Adam in His image. After Adam contracted the S.I.N. virus, he became subject to the Law of Entropy, or the Second Law of Thermodynamics. He and Eve, now isolated from their divine source, became “Human”, entities trapped inside of total disorder (entropy) that over time move toward a state of maximum disorder or “death”. As the first “Humans”, every male and female created from the intercourse between a male and female are descendants from Adam and Eve.

Thus, all humans from every tribe, nation, and tongue are born equally isolated from their divine creator, Christ Emperor King Yashiah. Equality under the Second Law of Thermodynamics (i.e., the birth and death cycle) does not mean all humans are born identical and, as world history and present day social relations prove, all humans are not treated equally under global law. Yashar'Elite laws were designed to provide rights and protections for both males and females, whether you were a child or an adult.

However, through freewill, tradition and the major influence of maniacal Invisible Forces that govern the world through systems of disorder, Humankind repeatedly engineers civilizations and societies that are incapable of creating a harmonious and prosperous reality for everyone. The Royal Rights and Liberties of the United Kingdom of Yashar'EL are purposed to help its citizens, both Yashar'Elite and Gentile, live a life pleasing to the Most High YAHAWAH.

Section 1. The judicial process of Yashar'EL shall be open to every person within the jurisdiction of the CPOYI. Speedy and certain remedy and equal protection shall be afforded under the laws of HM Yashiah.

While the Royal House of Yehudah's emergency government and sovereignty is legal, and serves to protect the Covenant adhering Yashar'Elite diaspora, it operates under limitations concerning its justice system. The Office of the CPOYI is purposed to prevent foreign governments from abusing their power, ensuring due process and holding accountable every member state of the United Nations that willfully or unknowingly violates the Universal Declaration of Human Rights.

Section 2. As a Yashar'Elite, you cannot claim immunity of criminal laws of the country you reside. Yet, host governments are required to perform their official duties without harassment, or inappropriate behavior. In all criminal proceedings, the accused Yashar'Elite representative of their sovereign state shall have the right to: counsel; confront all adverse witnesses; have a compulsory process for obtaining witnesses in favor of the accused; and, to a speedy public trial by an impartial jury. The accused shall have the privilege against self-incrimination. The host government shall not twice try or punish an accused for the same offense. Excessive bail, nor excessive fines shall be imposed, nor cruel and unusual punishment inflicted.

Section 3. The right of trial by jury shall remain inviolate, thereby facilitating the free flow of communication and maintaining peaceful international relations. The United Kingdom of Yashar'EL and host governments shall not deprive any person of life, liberty or property without due process of law. Private property shall not be taken for public use without just compensation. This agreement of protections for Covenant-adhering Yashar'Elites in the diaspora will ensure a reciprocity of fairness and respect when Christ Emperor King Yashiah returns to establish His Kingdom on Earth.

Article V. SUPERSEDES INTERNATIONAL CONVENTION AND ELIMINATES ALL FORMS OF AUTHORITARIANISM

For the Covenant-adhering North American Yashae'Elites including the Yashar'Elite diaspora involved, the provisions of this Constitution overrule, and supersede and repeal the provisions of local, state, nation and global discrimination laws. The comprehensive national legislation, academic curricula, and religious teachings negating our identity are also null and void. The politics have that limited our peace and security have resulted in insufficient protections in commerce, trade, the general business and job markets.

Article VI. SEAT OF GOVERNMENT

The Seat of Government of the United Kingdom of Yashar'EL shall be in Western North Carolina, USA.

Article VII. DIVINE SANCTION OF SOVEREIGNTY

This Constitution shall become effective October 16, 2025. In conformance with the established divine law as recorded in the Record of Daniel 12:1 and more recently The Divine Right of Kings, the political-religious doctrine that upholds English monarchical authority, Crown Prince Mikell is the head of state of the United Kingdom of Yashar'EL and its citizens in the diaspora. Therefore, the Royal House of Yehudah Constitution shall be signed by HRH Mikell as the Office of CPOYI's authorized representative. It shall be filed in the Office of the CPOYI and sacredly preserved as the fundamental law of the United Kingdom of Yashar'EL.

The Constitution shall be printed in English, for all legal purposes. **The Royal House of Yehudah Constitution** shall be printed and submitted to the International Court of Justice for record.

No petitions or proposal for the amendment of this constitution shall be submitted to the Office of the CPOYI by a non-Yashar'Elite individual or entity.

Article VII. ABSOLUTE MONARCH AUTHORITY

NOW, THEREFORE, WE, by the rights and powers of OUR Prerogatives as Ministers and Dependencies of The MOST HIGH SOVEREIGN AND HOLY ONE YAHAWAH, HEREBY PROCLAIM in the NAME of HIS MAJESTY CHRIST EMPEROR KING YASHIAH and on OUR behalf and for and on behalf of OUR Successors as hereinafter accept the King and Savior of Yashar'EL's exercise of executive authority, now and forevermore as Constitutional Covenant Keepers. SO BE IT.
