SETTLEMENT AGREEMENT

The Plaintiff, LONG LEAF PLANTATION HOME OWNERS ASSOLT-ATION, INC., and the Defendants, ELEODORO DECASTRO and DIANA DECASTRO, hereby stipulate that this case shall be dismissed with prejudice, upon the following basis:

- The Defendants have removed the non-conforming pool enclosure that was the subject of this suit, and thus the Defendants are now in compliance with the covenants and restrictions.
- The Defendants agree to pay to the Plaintiff on or before June 30, 1993 the sum of \$400.00 as a partial reimbursement of the attorney's fees and costs incurred by the Plaintiff in the prosecution of this suit. Payment shall be made to the attorney for the Plaintiff, by check payable to the Taylor and Early, P.A. Trust Account. If the \$400.00 is not paid in full by June 30, 1993, then the Defendants agree to pay the sum of \$1,016.50, representing the entire amount of the fees and costs incurred by the Association, which sum shall become due and payable on July 1, 1993. In addition, the higher sum shall bear interest at the rate of 12% per annum from July 1, 1993.
- Upon the signing of this Agreement by all parties, and upon the delivery by the Defendants to the Plaintiff of a notice of dismissal or other satisfactory evidence that the Defendants have dismissed their complaint filed with the Florida Commission on Human Relations, Case No. 93-3432, and with the U. S. Department of Housing and Urban Development, Case No. 04-93-0200-1, with prejudice, the Plaintiffs shall dismiss this suit with prejudice.
- In addition to the dismissal of their respective actions, each party does hereby remise, release, acquit, satisfy, and forever discharge the other of and from all, and all manner of actions, causes of action, suits, damages, claims and demands whatsoever which either party ever

had, now has or may have in the future against the other party arising out of the subject matter of their respective actions; provided however, this general release shall not apply to any other violation by the Defendants of any of the Long Leaf Plantation subdivision covenants and restrictions. This release by the Defendants shall also apply to those individuals named in the Defendants' complaints filed with the Florida Commission on Human Relations and with the U. S. Department of Housing and Urban Development, namely, Joyce Monaco, Fred Collins, Nancy Grant, Diane Smith, Julie Irezarry (Irizarry), Bob Hessler, and Charles Early, P.A.
