### Flourless Chocolate Cake

#### Ingredients:

6 Tbsp unsalted butter (room temp) 2/3 C walnut pieces 3/4 C & 1 Tbsp walnuts (chopped) 8 oz dark chocolate, (chopped) 3 Tbsp unsweetened cocoa powder 1/4 tsp baking powder 1/4 tsp salt 1 C granulated sugar 4 lg eggs 1 1/2 tsp vanilla extract

Garnish Chocolate shavings Raspberries with sauce

#### **Directions:**

Preheat oven to 350°. Grease an 8-inch spring-form pan with a small amount of butter. Set aside.

Place 2/3 cup of walnuts in work bowl of a food processor & pulse until coarsely ground. Set aside.

Place chocolate in a microwave-safe bowl & heat on high in a microwave at 30-second intervals, stirring between intervals, until chocolate melted & smooth. Set aside.

In a medium bowl, stir together cocoa powder, baking powder & salt.

In a separate bowl, cream together butter & sugar. Add eggs one at a time, beating well after each addition. Continue beating until mixture is pale & creamy; about 5 minutes.

Spoon in chocolate & vanilla & beat until just blended. Fold in ground walnuts, chopped walnuts, & cocoa powder mixture.

Pour into prepared spring-form pan & bake until cooked through; about 35 minutes.

Let cool completely on a wire rack. Run a small knife around the edge before releasing the sides of the spring-form pan.

Serve at room temperature & garnish with chocolate shavings & raspberries in raspberry sauce.
