THE NYSC PROFESSIONAL EXAMINATION SCHEME (PES)

The ICPSP NYSC professional examination scheme is designed for candidates to develop the knowledge and skills required to work in a range of corporate and public services in Nigeria and other parts of the World. The scheme is formed of mandatory and optional courses. The mandatory courses cover core competencies that have been categorised around the following four key themes:

- Leadership in the Public Sector
- Strategic Management within Corporate Setting
- Innovation & Entrepreneur
- Principles & Values

The optional courses allow candidates to choose from corporate or public sector focus pathway. The choice of pathway is that of the candidate who will ensure his/her option reflects the context of their prospective work or desire career route.

MINIMUM ENTRY REQUIREMENTS: All NYSC CORPS members. Interested candidates who are not currently NYSC CORPS membership will need to hold a minimum of OND (with five years working experience). Candidate holding membership of other professional bodies approved by the Institute National Executive Council can also enrol on the programme.
