With respect to the matters specified herein, this CONTRACT constitutes the entire and exclusive agreement between the Parties and supersedes all other agreements. No waiver or modification of any of the terms or conditions hereof shall be valid or binding unless submitted in writing, approved and signed by the SCHOOL. The SCHOOL reserves the right to make the final decision on the initial and continued enrollment of any child.
