Welcome to the age of Artificial Intelligence in criminal case analysis. The below example using public sources for content public sources for speech recognition and public sources for audio analysis of all participants.



This 27-minute recorded Jail call was summarized and analyzed within a few minutes of computer time. Inclusive of the human that conducted the workflow to convert audio to text for analysis and develop the questions, 20 minutes or less was used to produce this artifact.

The Call audio was submitted with a request to correct speaker change errors not recognized during the ASR process, no human post editing was used, this is Raw results.

- No domain training was used to improve this content.
- No human editing was required.
- Content and even AI models can be processed in private/secure environments
- This level of Analysis is available today for investigators and trainers

Voice and Tone Analysis: Kessler's tone is persuasive, attempting to control the narrative. Vocal analysis might suggest stress or defensiveness, aligning with her inconsistent narrative.

Sentiment and Emotion Detection: Kessler predominantly showcases emotions of frustration and desperation. The external contact exhibits worry and a genuine intent to assist.



Paralanguage Analysis: Subtle non-verbal cues from Kessler, like pauses or emphasis on certain words, suggest a desire to manipulate the narrative and might indicate deception.

Deception Detection Analysis: Kessler's inconsistent claims coupled with her evasive answers raise concerns about truthfulness.

Cultural and Regional Profiling: No significant indicators in the call to denote specific cultural or regional influences affecting the dialogue.

Conclusions & Recommendations:

- 1. The retrieved possessions should undergo a detailed examination for potential evidence.
- 2. Kessler's statements need further scrutiny for inconsistencies.
- 3. It is essential to conduct an interview with Kessler's public defender to gather more information.
- 4. Considering the sentiment analysis and potential evasion, a deeper voice and tone analysis might shed light on underlying emotions and truths.

By approaching this case through a multi-faceted forensic lens, it becomes apparent that while no direct admissions were made, the inconsistencies and evasive nature of Kessler's remarks require further exploration. The intersection of behavioral, linguistic, and anthropological analyses can provide a comprehensive understanding of the dynamics and credibility of the call.
