At From the Core LLC – Denver, Colorado, accessible from faithvictorialee.com, one of our main priorities is the privacy of our visitors. This Privacy Policy document contains types of information that is collected and recorded by faithvictorialee.com and how we use it.

General Data Protection Regulation (GDPR)

We are a Data Controller of your information.

Faithvictorialee.com legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Information we collect and the specific context in which we collect the information:

- faithvictorialee.com needs to perform a contract with you
- You have given faithvictorialee.com permission to do so
- Processing your personal information is in faithvictorialee.com legitimate interests
- faithvictorialee.com needs to comply with the law

Faithvictorialee.com will retain your personal information only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your information to the extent necessary to comply with our legal obligations, resolve disputes, and enforce our policies.

Log Files

Faithvictorialee.com follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet

Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

Cookies and Web Beacons

Like any other website, faithvictorialee.com uses 'cookies'. We only use one cookie on GoDaddy hosted websites. We use this cookie to count the number of unique visitors, so we know how many people visit the websites we host and to report that to faithvictorialee.com 's website dashboard. This cookie is not used for anything else beyond this. It does not use or store any personally identifiable.
