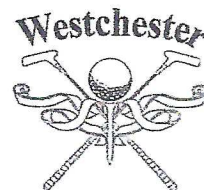

Meeting called to order at 12:15pm. 31 members in attendance.

Vice-President / Handicap report (Toni Mannix)

A letter to Westchester WGA from SCGA was read into the minutes by Pat Martzen. (attached)

Because of this letter, effective immediately WWGA members are NOT to use our WWGA buff cards; but must use WGC scorecards AND enter scores hole-by-hole to insure SCGA approved adjustments. Eventually SCGA database will be corrected (Women's H/C of holes) and we can return to using our WWGA buff scorecards.

Nancy Mandoky provided the background on this issue. The WGC scorecard lists hole #3 as the most difficult hole. The handicapping of holes is the same for men and women. Because this is clearly not accurate many years ago Nancy invited SCGA reps to come play a round and evaluate the course vis-à-vis slope, rating and hole handicapping. They concurred the existing data was inaccurate. Slope and rating was adjusted. Revising the hole handicapping proved to be onerous; and still has not been corrected. Nancy has had many conversations with WGC management (past & present) since then. The current disposition is that when the current supply of (inaccurate) WGC scorecards is depleted the change will be made.

Major Tournament report – Dallas Poffenroth

WWGA Championship is scheduled for 3 consecutive Tuesdays – August 1, 8, 15. Information on the bulletin board. Flyer will go out July 1.

There was a discussion as to what constitutes a qualifying WWGA round for purposes of the Club Championship. At issue is: should representing WWGA at team play count; should WWGA play away rounds count.

Result: Defeated

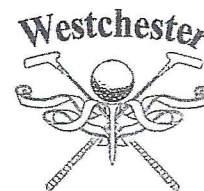
VOTE: Should WWGA Play away* rounds count

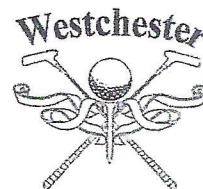

Roster-as of June 2023

Dear Westchester WGA,

It's been brought to our attention that your club is instructing members to not post their weekly play scores as hole-by-hole in the GHIN Mobile App/GHIN.com.

Recognizing that a club, or committee in charge of a competition, can have their own stroke index allocation, as your club does, when it comes time for score posting, the scores must be posted using the published stroke index allocations in GHIN.com/GHIN Mobile app. In other words, your members must post their scores each time they play, or the club needs to post for them, ensuring any adjustments done for net double bogey, etc. are done based on the published stroke allocation, not what's on the Westchester Women's Golf Association scorecard. In this case, the players (or the club) would have to make any manual adjustments for net double bogey and then post the total score or enter their hole-by-hole information and allow the software to adjust any scores based on the published stroke index.

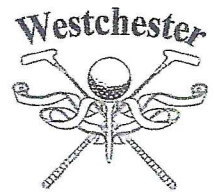
