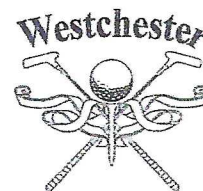

Spring Fling went well. 37 ladies attended. The next social will be in August in conjunction with the Club Championship. Venue TBD.

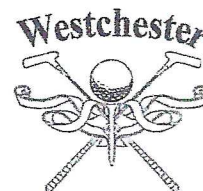
There was a general discussion on raffles at luncheons. Historically the "Fall" (championship) luncheon has had an extensive raffle. In recent years that has not necessarily been the case, and there have been simpler raffles at the holiday luncheon. In general the board was in agreement on the following:

- Donated "promotional/logo" items were not generally well received
- Raffles generate **substantial** work for the organizer (additional volunteers are mandatory)
- Membership loves to win golf outings and restaurant GC, but most golf items are superfluous. We are all generally in "purge" modes and do not need more stuff.
- The monies generated are not necessarily needed; and unless we are raising funds for a particular cause raffles are not necessary
- When in possession of desirable prizes (golf, gift cards & the like) a door prize format for all in attendance is preferred.

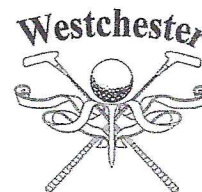
## Next Meeting
