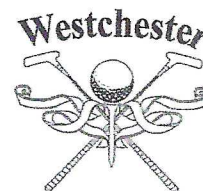

March 21, 2023 – WWGA General Meeting

Hacienda del Rey Restaurant

Meeting called to order at 12:15pm. 19 members in attendance.

Minutes of General Meeting held on January 24, 2023

- Sheri Wiggett moved that minutes be approved
- Bonnie Keady seconded
- Motion approved

Treasurer's report (Sheri Wiggett) –

- March beginning balance: \$8,532.57
- March ending balance: \$8,696.57
- Accrued expenses (\$ 545.00)

Vice-President / Handicap report (Toni Mannix)

Toni addressed question regarding posting when less than 18 holes are played:

- Play <7 holes – Do Not Post
- Play 7 – 14 holes – Post 9 holes (post par + pops score for holes not played)
- Play >14 holes -- Post 18 holes (post par + pops score for holes not played)

Toni requested that "adjusted score" be noted for ALL players on the scorecard. She also indicated that a -1, -2 notation below the hole score on the scorecard is helpful.

Toni requested (again) that you "turn" the picture of your scorecard prior to sending. It is a simpler process for the sender than for her, on the receiving end.

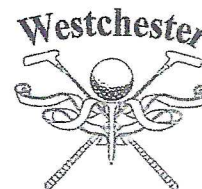
The question regarding what score to put on the score card when a player picks up her ball (does not complete the hole). The rule is: the player enters her most likely score (what she likely would have had) up to her equitable maximum (par + pops + 2); and clearly marks an "X." The question stems from a player who is currently at 10 strokes, and has her approach and 2 putts for a "likely" 13, but her maximum is a 9. The concern was stated that entering a 9 unfairly impacts her score for competition. It is important to note that any "x" generally disqualifies the participant from any competition so that concern is moot.

Major Tournament report – Cindy Denny/Dallas Poffenroth

There was a discussion about the President's Cup, and why it was cancelled. Only 13 players registered (ideally there would be 32). Question as to what is the reason for this poor showing...

- ? Because it was a 3 week commitment – 3 members responded "yes"
- ? Because it is match play – 5 members responded "yes"
- ? Would you be more inclined to participate in a partner match play event – 9 members responded "yes"
- ? Because it coincides with WPLGA Team (match) play schedule – 1 member responded "yes"

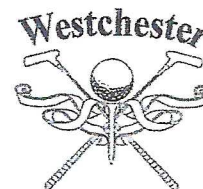

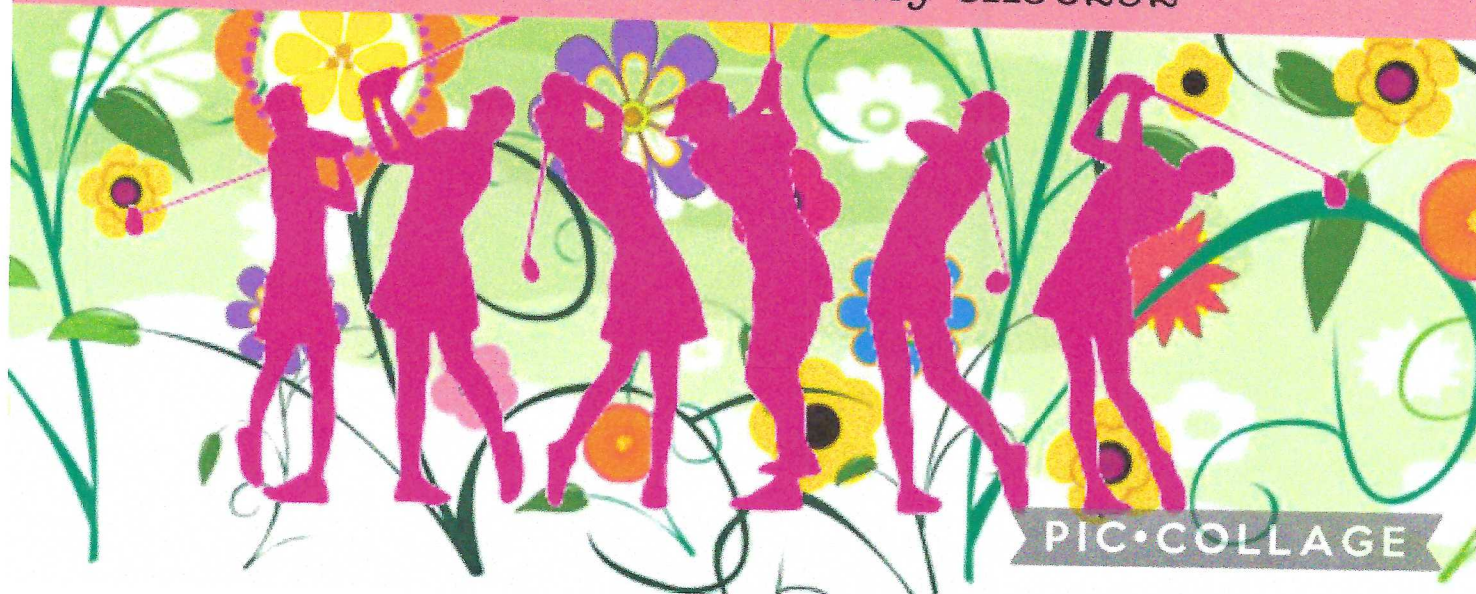
