Discussion

Low Net Budget - Due to the complete revision of the Low Net Program there was lengthy discussion regarding prizes. The board agreed on the following:

Trophy budget – The only trophy WWGA still awards is the perpetual Championship trophy. At this time the trophy is "full" with no room to add additional names. The 2023 proposed budget of \$400 is for a new trophy. There was general discussion that now is the time to revisit the notion of a perpetual wall plaque/trophy to be in the WGC Pro Shop/Café area. Pat will discuss with WGC GM. Budget will stand for now, but actual use is pending.

Play Away budget - Various opinions re: budget (subsidy) vis-à-vis guests were shared. In the end it was agreed the the general expectation is that the event is to be self-sustaining. Non-member guests pay a modest upcharge and are eligible for prizes and swag. The budged amount was left in place for unexpected expenses, hopefully not used.

Club Champion Play Registration budget – This has not been used for a few years. Discussion as to why revealed that the scheduling of the WWGA Championship Tourney to later in the year (from summer to October) results in insufficient time for the Champion to plan/schedule participation in the November tournament. It was agreed to leave the budget as is, and look to rescheduling the Championship earlier in the year.

Social budget – Lengthy discussion of 2022 budget vs. expenditures for each luncheon; noting a wild swing between luncheons (surplus and loss). In the end the bottom line was a "wash." It was agreed that the budged amount would be \$1,000 and the Social Chair could allocate as needed, ending the year on budget. Motion made by Jane Wortman, 2nd by Sally Elenitsky, and approved. The treasurer will account/itemize as she deems appropriate. It was also noted that all contracts are to be reviewed by the board prior to execution and the board will approve pricing for each luncheon based on the contract.

Computer development budget – It was agreed to put a \$1,000 budget for website development. That project will be deferred to Spring, at the earliest.
