## THE FOLLOWING WAS DISCUSSED & APPROVED FOR THE CLUB CHAMPIONSHIP

- Due to budgetary concerns, there will not be complimentary food for this tournament only for the year end tournament.
- Summer rules will be played all over play the ball as it lies.

- Sand traps will be in play with the exception of #12 and any others that are deemed necessary with the determination being made the day before the tournament. Players will be permitted to lift a ball in any trap, smooth the sand as necessary, and replace within 6 inches of original spot.
- Dona will email the membership alerting them that traps will be in play with any exceptions being noted on the information sheet provided with score cards on the day of the tournament.
- Pairings for ladies and men:

Day #1 – Pairings will be based on handicaps (i.e. lowest handicaps in first group, next lowest in next group, etc.). Lowest handicaps will tee of first with highest handicaps teeing off last.

Day #2 – Pairings will be based on scores from Day #1, with low scores grouped last. (Ladies will still tee off first.)
