TOURNAMENT RULES

Discussion regarding the option of using winter rules for certain tournaments. It was agreed that we will try this at the next tournament on July 23rd. Each score card will include a written explanation stapled to the card saying: "Winter rules in your own fairway for a poor lie. Ball must be placed within one club length no closer to the hole."

LADIES' SENIOR TEES

Karen requested that we discuss the need for ladies' senior tees. The board agreed that we should pursue this. However, the course/new tees will have to be rated by the RDGA. Deb will talk to Cindy to see if HR is agreeable to this. Dick will check with the RDGA to see if HR is on the schedule to be rated next year, and will also tell them we want to add another set of tees.

TOURNAMENT SKINS PAY-OUTS

Larry asked about the process for tournament skins pay-outs. Dick reported that the money is kept separate for the men and for the women. For scramble events, it's a team event, so there is one pot of money for everyone. For the July 23rd tournament, which is a two-person best ball, even though there might be mixed teams, there will not be a separate mixed skins pay-out because everyone will be playing their own ball.
