

## How it works:

Safe Baby Court works to help families identify exactly what they need to be successful long-term. Cases initiate with a willing and motivated parent who is committed to the hard work it will take to regain custody of their child. That parent is then met with a team of professionals to support them on their journey.

### Team Approach:

Attorneys, child welfare workers, certified peers, case managers, child development specialists and more are involved. Everyone comes together monthly to talk through progress and struggles and to help families problem solve.

### Court:

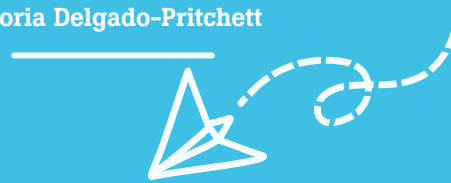
Cases are heard in court monthly where further collaboration ensues thereby ensuring steps towards permanency are always moving in a forward direction.

While reunification is our primary goal at SBC, ultimately, helping children achieve a safe and stable, forever home is at the heart of our work. There are times, through the support and work they've done in SBC that parents realize that forever home may not be with them and kinship placement is an alternate and positive outcome of our work.
