## Police Log

The Hampton Township Police Department is dedicated to enhancing the quality of life of our residents and guests by providing the very best in law enforcement services. The twenty-two officers and two civilian clerks take pride in serving the community in a professional and proactive manner. Thank you to the staff for helping to keep our community safe.


A summary of noteworthy incidents that occurred between July 22<sup>nd</sup>— August 27<sup>th</sup> 2018:

### Drug Arrest

 On July 19, 2018 at 11:26 p.m., a Hampton Township officer initiated a traffic stop on a vehicle on Walters Road, after observing an equipment violation. Upon contacting the vehicle occupants, the officer detected the odor of burnt marijuana emanating from the vehicle. Upon further investigation, the officer located drugs and paraphernalia within the vehicle.

 On August 6, 2018 at 5:10 p.m., a Hampton Township officer observed an individual walking through a business parking lot. The individual was observed to be visibly shaking and was unsteady on their feet. Upon the officer contacting the individual, who had proceeded to sit on the side of the parking lot, the individual appeared to be disoriented, had constricted pupils, and spoke very slowly. The individual was found to have an active arrest warrant and was placed under arrest. The individual was also found to be in possession of drugs and paraphernalia.


### Theft from Vehicle

 On July 27, 2018 at 10:05 a.m., a resident from Canterbury Drive responded to Hampton Township Police Department to file


a theft report. The resident reported that an unknown person (s) entered their two unlocked vehicles, which were parked in the driveway, sometime during the overnight hours. The actors stole approximately \$200.00 from the vehicles.

attempting to turn left into a parking lot, and crossed into the path of the oncoming motorcycle. The motorcycle sustained severe damage and was towed from the scene. The involved vehicle was able to be driven from the scene.

 On July 22, 2018 at 10:31 p.m., Hampton Township Police responded to Cedar Run Road for a single vehicle accident, with the involved vehicle reported to be on fire. Upon the responding officer's arrival, the fire had already been extinguished by a good Samaritan who lived nearby. The operator stated that they were traveling too fast for conditions on Cedar Run Road, when they lost control going around a bend in the roadway due to a recent rain that left the roadway slick. The vehicle then struck a utility pole and the engine caught fire. The vehicle was towed from the scene.

 On July 28, 2018 at 4:37 p.m., Hampton Township Police were dispatched to Route 8, at McNeal Road, for a three-vehicle accident with injuries. Upon the officer's arrival, two vehicle occupants were found to be complaining of chest pain. The accident occurred when one operator rear-ended a vehicle that was stopped at a steady red light in the curb lane of southbound Route 8. Witnesses stated that the vehicle's operator never appeared to hit their brakes prior to the impact. The operator stated that they were momentarily distracted, and by the time they saw the vehicle stopped ahead, they

## A Viable Alternative Energy Source

Solar panels are popping up all over Hampton Township. Currently, there are fifty-five homes that have gone solar with two more undergoing the permit process.

George and Carol Andrews of Oakhurst installed solar panels on their home a little over a year ago. So far, they are pleased with their panels and the work of Solar City, who was later bought out by Tesla. "There is zero money to pay up front for the installation," said Andrews. "And even though we are currently saving about \$20 a month with solar, we didn't do it for the money. We did it for the clean energy."

There is a lot of freedom in the process. A homeowner can essentially rent the panels with their only cost going to their solar provider each month for the energy used. When you choose this option, like the Andrews did, Tesla will take the Federal and state's renewable energy tax credit. Or, you can opt to pay off the panels in monthly installments in effort to own them once their paid off and receive the renewable tax credit for yourself. You can also choose however many panels you want to put on your roof. Of course, the more panels you opt to have, the more energy they will produce.

"Soon," Andrews said, "They are coming out with panels that will just look like shingles."

Another Tesla customer who lives off of East Hardies Road said that the only problem he has encountered with the panels is that

there is not enough sun in Pittsburgh.

Anyone who switches to solar will pay their solar provider for their electricity, but anything that their panels were unable to produce will be covered by their current provider, most likely, Duquesne Light. "In December, my bill for the solar was only \$10. The balance of my energy bill went to Duquesne Light due to the lack of sun," stated the homeowner. "It also took a long time to get the process going. The average is 6-8 months once all the paperwork and permits go through."

Although approval is needed from the township, as of now, there should be no additional fees for putting on solar panels. During the public hearing of the Hampton Township Council on July 11<sup>th</sup>, an ordinance was passed in regard to solar panels. As quoted from the minutes at that hearing, "Mr. Orban explained that the Building Code regulates the construction and installation of these panels; however the Volunteer Fire Departments have requested designated access points and a pathway to the roof that is free of solar panels."

They are also requesting signage that is visible from the street so the firefighters will know if the home contains panels.

"Mr. Orban replied that the regulations will only apply to new installations moving forward," the ordinance states.

Andrews definitely says he would recommend solar to others and not just because he gets a referral fee. "I'd love to see more homes opting for solar. The technology is there to help our earth. We just have to take advantage of it."

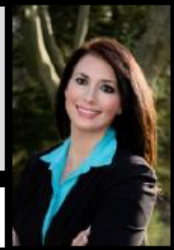

were unable to stop quickly enough. The force of the collision caused the rear-ended vehicle to strike a third vehicle. Two vehicles had to be towed from the scene due to substantial damage.

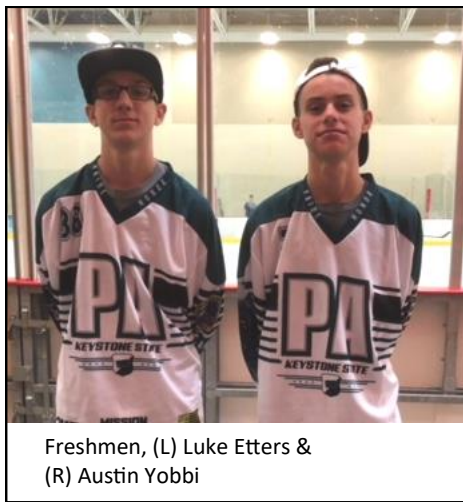

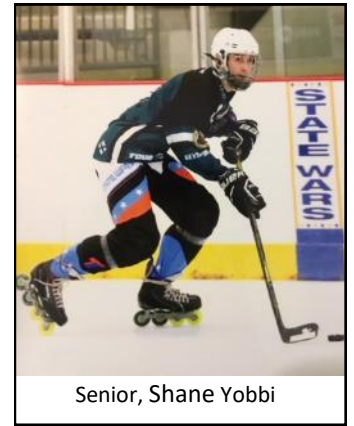

one vehicle was stopped due to an active construction zone, and was rear ended by the other vehicle. The injured driver was taken to the hospital by ambulance. One vehicle had to be towed from the scene.

On August 22, 2018 at 6:55 p.m., Hampton Township officers responded to Route 8 for a single vehicle accident with injuries. Witnesses who remained on scene stated that the vehicle was traveling south on Route 8 when it suddenly jerked sideways and collided with a guide rail. ble to complete field sobriety tests as had been explained and demonstrated and was arrested for DUI. The operator was also found to be in possession of paraphernalia.

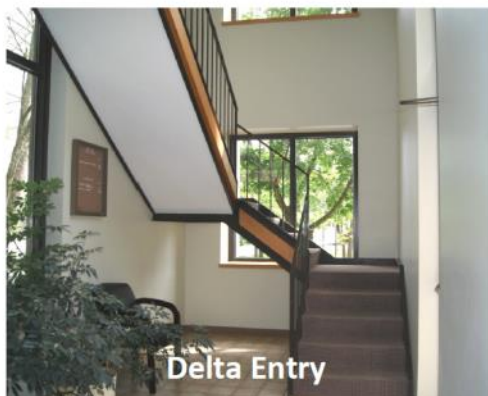

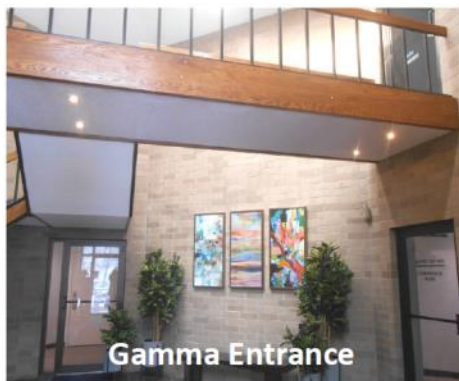
