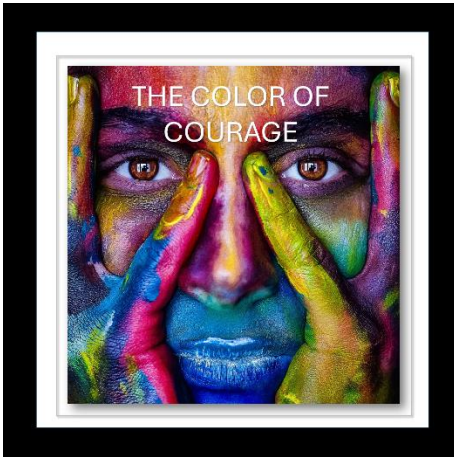

Dear Applicant:
