# RULES AND REGULATIONS WAHOO EXTRAVAGANZA

Welcome to the Annual Texas Wahoo Extravaganza.

#### **REGISTRATION:**

- 1. Boat Entry Fee is \$2,000 per Boat.
- 2. 1st and 2nd Place Pay-outs (29 or less Boat Entries):
  - 1<sup>ST</sup> PLACE 80% PAY-OUT
  - 2<sup>nd</sup> PLACE 20% PAY-OUT
- 3. If the Boat Entries Exceeds 30 Boats the Pay-out will change to the following:
  - 1<sup>st</sup> PLACE 70% PAY-OUT
  - 2<sup>ND</sup> PLACE 20% PAY-OUT
  - 3<sup>RD</sup> PLACE 10% PAY-OUT

#### **RULES AND REGULATIONS**

- 1. The Wahoo Extravaganza will begin at 12:01AM January 1, 2026 and ends on March 31, 2026.
- 2. All Boats must leave from a Texas Port and return to a Texas Port.
- 3. The entry into the Wahoo Extravaganza is per Boat not Angler. The Anglers can be switched but the Registered Boat has to be the boat all Fish are caught on. (The Registered Boat may be changed prior to start of Tournament before December 31, 2025)
- 4. All Fish must be weighed in at a designated weigh station that is participating in the Wahoo Extravaganza. (NO EXCEPTIONS)
  - No Private Certified Scales Allowed.
  - Once Fish is weighed in at a designated weigh station a signature is required from the Weigh Master along with two Witness Signatures on the Wahoo Extravaganza Certified Weigh In Form. (Witness Signatures may not be from your Team)
  - You have 24 hours to turn in your Weigh in Paperwork via text message once the registered Boat hits the Dock.
  - Wahoo Extravaganza has 3 Committee Members that will be available for you to contact if any discrepancies arise at weigh-in. (We suggest not to leave weigh station before you get conformation your fish weigh was accepted)
  - All Fish Weighed in, Must be on a Hanging Scale at Designed Weigh Station.
  - Picture or Video Required: The Video or Picture must include the Fish Hanging on Scale with the weight visible

in media. (Any doubts do not leave weigh station without committee conformation the media provided is good)

- 5. Any Mutilated Fish will be disqualified from weigh in.
- 6. No Commerical Boats, No Party Boats are allowed.
- 7. Acceptable Entries: Private Boats, Charter Boats with max six pack licensing or less are Eligible.
- 8. In case of a Tie: The First Boat to register their last fish weighted in wins.
- 9. No Electric or Hydraulic Reels Allowed. All Fish must be caught on Conventional Tackle, Rods and Reels
- 10. All State and Federal Fishing Rules must be followed.
- 11. Winners are subject to a Polygraph Test. If you fail polygraph test or caught cheating in any way we will prosecute to fullest extent.
- 12. No More than 3 Fish are allowed as an aggregate weight to win.

## Monthly Sponsorship Pots:

- January: The Heaviest 3 Fish (must have 3 Fish) combined for the month of January will win \$2,000 (Donated from Sponsor not monies from main pot.)
- February: The Heaviest 3 Fish (must have 3 Fish)
  Combined for the month of February will win
  \$2,000 (Donated from Sponsor not monies from

- Main pot.)
- The Single Heaviest Fish caught in the whole Tournament will win \$2,000 (Donated from Sponsor not monies from main pot.)

### Winners

- The Winners of the 3 month Tournament will be presented with 100% Pot Entry (80/20 1<sup>st</sup> and 2<sup>nd</sup> Place or 30 Boats or more 70/20/10 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup>)
- All Participants will abide by any Decisions made on Exceptions or Discrepancies to the Tournament by the Three Man Committee Vote and will be Final no Exceptions.
