

# SPRING CREEK ASSOCIATION ANNUAL PROPERTY OWNER MEETING MINUTES

CALL TO ORDER: Chair Featherston called the meeting to order at 12:00 PM.

### PLEDGE OF ALLEGIANCE.

### I. PRESENTATION OF THE VOLUNTEER OF THE YEAR AWARD TO JODY WITHERS NON-ACTION ITEM

President Bahr introduced the Volunteer of the Year award recipient, Jody Withers. Jody volunteers endlessly at the Horse Palace.

Jody was present and thanked the staff and Board for the award.

## II. PRESENTATION AND UPDATE BY SOUTHWEST GAS. NON-ACTION ITEM

Dan Hayes and Dillon Keith were present for Southwest Gas. They stated that they currently have 435 active meters in place along with 750 service lines installed in Spring Creek. They commented specifically on their attempts to improve their restoration of disturbed areas by hiring additional crews. There were specific comments on the price for natural gas and the conversion for homes. Much of the information is available on their website at Springcreekgas.com.

- III. PRESENTATION AND UPDATE BY ANTHEM BROADBAND. NON-ACTION ITEM. There were no representatives from Anthem Broadband in attendance at the meeting to provide an update.
- IV. PRESENTATION AND UPDATE BY CC COMMUNICATIONS. NON-ACTION ITEM James Nugent was present for CC Communications and provided updates to their current construction in the 200 and 400 Tracts. He commented that their contract is non-binding and

there is no cost to property owners for hooking up service while they are working on their grant funding. They will move on to the 100 and 300 Tracts next. Their webpage is elkobroadband.com and you can find updates on their progress there.

## V. PRESENTATION AND UPDATE BY ELKO COUNTY AMBULANCE. NON-ACTION ITEM

Chris McCann, Chief of Elko County Ambulance Service, was present and provided an update on the ambulance service in Spring Creek. It was approved to have full-time service in Spring Creek in 2020 and there has been full-time staffing available since 2022. They are hoping to remodel the fire station by the roundabout for the ambulance service.

Treasurer Austin-Preston provided an update to the property owners that the audit is complete and going through the quality control process.
