Attorney McConnell stated that once a proposal is accepted, many of the items of concern can be addressed in the contract.

Member Young moved/Member Featherston seconded to request proposals for the restaurant and/or bar services at the Fairway Community Center. Motion carried (6-0), Chair Park absent.
