Contract to grade dirt in the pit was signed and completed for \$9500, but not paid for. In the office for review. It was signed by Ralph Roach to get multiple compaction tests completed and move dirt into the pit. Discussions who is paying for the remaining dirt needed is still in the air. Talks are ongoing.
