#### \*Security Deposit

- A. Security Deposit shall be the greater of \$250.
- B. Security Deposit may be fully or partially withheld for one or more of the following reasons:
  - 1) Facility use fees for the time used in excess of time requested and reserved.
  - 2) Damage to the facility or equipment
  - 3) Misuse of the facility
  - 4) Inadequate clean-up by renter, requiring additional custodial time/services after renter's use.
  - 5) Early cancellation charges
- C. If fees/charges due exceed the amount of the Security Deposit, the renter will be billed for the balance.
- 1) Payment will be due within five (5) business days.
- 2)Future reservations may not be honored until all charges/fees are paid.
- D. It is the renter's responsibility to notify the Guild of any address or telephone changes
  - so the refund may be mailed to the correct address.
- E. Unused Deposit will be returned within 30 days of upon complete and clean departure of the facility
  - or, if earlier, witin 30 days of cancellation.
- F. Applcant must provide liability insurance with a minimum \$1 million liability coverage and an endorsement

that names the SVCTG, it's Board of Directors and employees as additional insured.
