A. 2022 Spring Flag Season

Kapua: we haven't received much information yet from Pop Warner Brenda: It is a little quiet up there but we can go ahead, modify what we need

Kapua: We can start getting the word out, reach out to your park directors to secure the fields for practice, also please update your point person for each park. I have already informed their bosses that we will be starting our season.

Kapua: I have been informed from Vice President Sean Hanohano that this season's flag referee fees have been increased, the amount I was given was \$85.00. I am in the process of confirming it with President Todd on the dollar amount. Will update once I receive word.

Kapua: All outstanding balances will need to be paid in full prior to the start of flag 2022

Hilo: Do we need to keep the Covid waiver with our registration Kapua: Not needed anymore

West Side: On the west side things are starting to escalate again, places are shutting down, i think we should still be on covid watch, we just canceled events for jr golf, other big events are canceled to Kapua: We are still going to push thru with a season, please be very clear with potential covid shut downs

Kapua: with your registration please include something with Covid plans, in the event we have to delay the season and/or shut down

Puna: Are we requiring our players to be vaccinated? Wellness checks?

Kapua: the players do not have to be vaccinated, we encourage daily wellness checks, i will forward documents from DOH via email

Krystle: What field size are we going to be using? Is it still 1 game on the east and the west side? Are all 11 associations coming back for the flag season?

Kapua: Brenda will send out the standard football field map. There are some fields that need to use the smaller field. They need to make a decision until we know what fields will have available. We will send out both dimensions - will that work?

Krystle: Can we keep the field consistent with all associations? Kapua: What say you presidents? Do you have a preference? Leeward: Smaller field

West Side: Flag 80 by 34, we shortened the field cause of 7 on 7 Brenda: 7 on 7 runs on a smaller field, 100 yard or 80 yard Via rule book: Flag 120 yards with 5 zones or 80 yards with 4 zones

Chad: In the past it was more accommodation side by side games

For example - Hamakua 100 yard field upper field, baseball

field 80 field, the 80 by 40 works whether its side by side or
a baseball diamond.
