#### X. New Business:

- ➤ Insurance payment still due by August 1st
  - 1. Our league general liability insurance only covers BIPWFC practices, games and regional and national events.
  - 2. It does not cover fundraising events or host concessions
    - a. Associations will need to purchase their own general liability insurance for all fundraisers, activities, and events.
  - 3. The Directors and Officers insurance that associations pay for now only

covers the BIPWFC Board Members that include the association presidents

a. Association Boards will need to purchase their own Directors and Officers insurance for their board members.

- ➤ Requesting to add to the next meeting agenda, raise the tackle minimum player requirement from 16 to 18.
- ➤ Request to add to the next meeting agenda the topic of Game forfeiting, and whether there should be a consequence.
