Tonya Myers Phillips is an attorney who advocates for equitable and inclusive public policies. Tonya currently serves as the Community Partnerships & Development Director for the Sugar Law Center for Economic & Social Justice in Detroit. In this

role, she develops relationships and attracts funding to support the work of the Sugar Law Center. Tonya also negotiates community benefits agreements (CBA) on behalf of community groups and promotes the expanded and intersectional use of CBA's as an equitable development tool.

Tonya also consults with Michigan Legal Services on housing policies for low-income families as the Public Policy Advisor. She is the ERASE Project Lead for "Keeping Detroiters in their Home" and the Project Leader for the Detroit Right to Counsel Coalition since 2019.

In the Fall of 2022, Tonya co-instructed the Community Advocacy Law Clinic at Wayne State University Law School; Ms. Phillips assisted in creating this year's curriculum to focus on advocacy in housing, economic development, and civic engagement.

Tonya has over eighteen years of legal experience and twenty-eight years of professional public service experience. Tonya received her bachelor's degree with honors from the University of Michigan and her law degree from the University of Michigan Law School. Tonya was selected to serve on the esteemed City of Detroit Charter Revision Commission from 2010-2012. She was honored with the Distinguished Young Lawyer Award from the Wolverine Bar Association and the Maryann Mahaffey Public Servant of the Year Award and the Community Advocate of the Year from the United Community Housing Coalition.

Ms. Phillips devotes valuable time to the community by serving on the Board of Directors for Community Development Advocates of Detroit, Sidewalk Festival Detroit, and her neighborhood block club. Tonya served on the Justice Policy Initiatives Committee and the Character and Fitness Committee for the State Bar of Michigan. Tonya has also served on the Board of Directors for Habitat for Humanity-Detroit, the Wolverine Bar Association, and Detroiters Working for Environmental Justice. She also serves as a member of the State Fairgrounds Development Coalition and with numerous other organizations.

Tonya is a native Detroiter who resides in Detroit with her husband and son and enjoys reading, cooking, and spending time with family and friends.

Linda Campbell is founding Senior Director of Detroit People's Platform (DPP). Detroit People's Platform is a community organizing group founded by Detroiters in response to emergency management takeover of Detroit a decade ago. DPP is also active in national and statewide coalitions advancing equity and racial justice.

Detroit People's Platform organizes with majority Black Detroiters to build power and win important public policies that improve the material wellbeing of low income Detroiters.

DPP is a founding member of Equitable Detroit, the city-wide Community Benefit Coalition, and the Detroit Affordable Housing Trust Fund. In addition, DPP organizes with bus riders to improve DDOT bus services for those who depend on public transit as their primary means of transportation.
