# **Seniors Farmers' Market Nutrition Program (SFMNP)**

**INFORMATION FOR PARTICIPANTS** 

# **Only 1 Voucher Booklet per Participant**

## **PROGRAM OVERVIEW**

The Seniors Farmers' Market Nutrition Program (SFMNP) is a summer-only program that provides eligible lower-income older adults with vouchers to purchase locally grown fresh fruits and vegetables, raw honey, and fresh cut herbs at NC SFMNP certified farmers' markets. The SFMNP is designed to improve the nutrition of older adults and increase business for local farmers and farmers markets.

**Program Eligibility:** Ages 60+, resident of a SFMNP participating county with self-declared household incomes of

no more than 185% of 2025 Federal poverty level (\$2,413/month for a 1-person household;

\$3,261/month for a 2-person household).

**Season Dates:** July 1 through September 30, 2025.

**Eligible Products:** Fresh fruits, vegetables, raw honey, and fresh cut herbs may be purchased with SFMNP

vouchers. (Vouchers CANNOT be used for eggs, meat, cooked foods, baked goods, plants,

crafts, or any non-food items.)

NOTE: The SFMNP is not an entitlement program, so SFMNP vouchers are not guaranteed. Even if a person meets the eligibility requirements, there may not be enough funds for all eligible persons to receive SFMNP vouchers.

### **VOUCHER DISTRIBUTION AND USE**

Applications and voucher distribution will be handled by participating local agencies in **June**. Participants should follow instructions in voucher booklet.

- Eligible participants will receive ONE booklet with a set of ten vouchers, worth \$50 total.
- Only NC SFMNP certified markets and farmers may accept vouchers.
  - A list of SFMNP certified markets will be on the SFMNP website, which can be accessed by scanning the QR code below.
  - SFMNP posters will be displayed by certified farmers who accept the vouchers.
- Change CANNOT be received from vouchers at markets. If purchasing an amount over the voucher(s) value, participants may pay the difference to farmers.
- Participants must sign the vouchers on the FRONT signature line (like a check) before redeeming with farmers.
- Lost or stolen vouchers cannot be replaced.
- Vouchers are valid July 1 through September 30, 2025. Participants should redeem all vouchers before September 30.
