#### **Expected Behaviors**

- Being suspended by the Club from footballing activities for a specified period including training and matches.
- Being required to leave or be sacked by the Club.

- Encourage each player to accept responsibility for their own behaviour and performance.

## League Officials

League officials conduct random spot checks throughout the season on all teams. Spot checks can happen at home or away games and their arrival will be unannounced, all league official carry identification and they will introduce themselves to you

If at any time during a game you are approached by a league official you must respect and do what is asked of you, this could be showing them your team sheet, identifying yourself or any player/players they question, failure to adhere to this will result in disciplinary action being taken against you.

## Disciplinary Officer

All issues dealt with by the Disciplinary Officer will be kept confidential and only discussed with Committee members as required.

The Disciplinary officer will remain impartial at all times, all issues brought to the attention of the Disciplinary Officer will be held on file for 12 months before being destroyed.

Example of issues but not limited to:

- Unacceptable behaviour of a Player, Parent/Carer, Manager/Coach which has brought on a complaint.
- Any misconduct or breaking of Club rules by a Player, Parent/Carer, Manager/coach which has brought on a complaint.
