CODE OF CONDUCT

Athletes understand that teamwork and the maintenance of discipline is the key to the success of the sports program. All athletes realize that the manner in which they conduct themselves in or out of uniform, directly reflects on the entire team. It is recognized that these rules and regulations are necessary to maintain morale, discipline and effective learning. Consistent enforcement of these rules and regulations is also necessary to ensure the safety and general well-being of each individual athlete. Participation in sports is voluntary, not mandatory. It is a privilege not a right and may be revoked by the coaches/ Directors when an athlete violates the rules and regulations.

By being part of an athletic team, you are accepting the fact that your actions are more prominent than those not associated with such an activity. Because of this, exemplary behavior is mandatory at all times, anywhere in the community and at all team functions where you are recognized as a representative of CI.

• THERE IS A NO DRAMA POLICY BETWEEN ATHLETES.

- Verbal altercations = benched (depending on severity).
- Physical altercations= Permanent dismissal for the remainder of the year.
- Promoting good sportsmanship by way of example is required at all times. Athletes must not use foul language at practices, at performances, camp or competitions, etc.
- Proper appearance is required at all times, with clothing appropriate to the occasion.
- Members must cooperate with all team members, officials, and coaches.
- All athletes of Chicago Infinity must conduct themselves appropriately on social media. This includes
 no foul language, the use of illegal substances, inappropriate dancing, and the use of inappropriate
 sounds/ music.
- Every attempt will be made to discipline fairly/equally, and to make consequences of actions known ahead of time. Parents will be kept informed of problem situations. Severity of, or repeated offenses may dictate harsher action, including removal from the camp.

ABSENCES

- Cheerleading is unlike other sports. We do not substitute members. Your presence is very important.
- Illness or other extreme emergencies are the only valid reason for missing cheer.
 - Illness with doctor's note, extreme emergencies, preplanned school functions or family events will be excused.
- Work Study Interns must attend every practice or they will be ineligible for the stipends.
- Absences due to work schedules are unexcused.


