It's **tax time** again! As the year winds down, the tax reporting forms begin to arrive and we want to remind you which ones we need you to accumulate and send to us with your tax information.

A few administrative items to note:

- > Please visit my new website, which can be found at www.garryslatnick.com.
- > Due to rising costs and to continue providing you with the best possible service, all personal and business *tax return preparation fees will be increasing* this year. If you have tax changes, such as a new Schedule C, that will increase the cost as well.
- ➤ If you are a business owner, please see the enclosed letter regarding the *Beneficial Ownership Information* reporting. This is a requirement which you will need to complete on your own for each LLC or business owned. Failure to do so will result in fierce penalties.
- ➤ We are hoping to offer *Pay-by-Refund* this year, where the cost of your tax preparation can be directly taken from your refund. Stay tuned!

To assist us in the completion of your 2024 income tax return, please do the following:

• Review your 2023 tax return. We need the annual information forms that are sent to you for tax purposes. Please see page 2 for documents needed for individual returns, businesses and rental properties.

There is a new form, the 1099-K, that many of you will receive from EBay or Facebook Marketplace sales, or for cash transfers using apps such as Zelle, CashApp, or Venmo. If you receive a 1099-K this year, please make sure to provide it to us, and be prepared for a phone call and some questions from us so that we can report it properly to minimize income tax or determine that tax does not apply.

This is a reminder that credits for home improvements are available and can provide you with tremendous tax benefits. If you installed a new furnace, A/C, boiler, heat pump, water heater, woodstove, windows, doors, insulation, solar or battery storage, please be sure to provide us with a copy of the invoice.

Similarly, if you bought a new electric or hybrid car in 2024 please be sure to provide that invoice copy as well

• Mail, email (taxinfo.ghscpa@gmail.com), or drop off your tax information to our office. If we have any questions or need additional information, we will call you. Your copies will be mailed back to you. Refunds can be directly deposited into your bank account. Please make sure to provide up-to-date bank account information.
