Texas Commission on Environmental Quality (TCEQ)

 - a. Seaport and Rail Yard Areas Emissions Reduction Program (SPRY), Projected Opening: April 2024
 - b. Rebate Grants Program, Projected Opening: May 2024
- 3. Rulemaking (https://www.tceq.texas.gov/rules/whatsnew.html)
 - a. Rulemaking and State Implementation Plan (SIP) Revision Draft Concept and Initiation Memo Title 30 Texas Administrative Code (TAC) Chapter 114, Control of Air Pollution from Motor Vehicles Inspection and Maintenance (I/M) SIP Revision. A rulemaking and SIP revision are necessary to implement two bills passed during the 88th Texas Legislature, 2023, Regular Session: House Bill (HB) 32971 eliminates the mandatory annual vehicle safety inspection program for noncommercial vehicles, effective January 1, 2025; and Senate Bill (SB) 21022 extends the initial registration and inspection period for rental vehicles to three years. Pending the results of a 2024 I/M fee study in progress, this rulemaking and SIP revision would also be necessary to adjust the maximum fee inspection stations are allowed to charge for an emissions inspection. Seventeen counties in Texas are subject to 30 TAC Chapter 114 I/M rules and the I/M SIP which includes Brazoria, Fort Bend, Galveston, Harris, and Montgomery Counties.

Texas eclipse April 8, 2024, the moon will pass over the sun in Texas from 1:30 p.m. to 1:50 p.m. the first total solar eclipse over Texas since 1878, and the last total eclipse viewable from the -United States until 2044. Totality will occur through the areas of Dallas, San Antonio, Austin and Fort Worth. TxDOT is also preparing highway signs to share messages saying,

FEDERAL & BEYOND

AM Radio for Every Vehicle Act of 2023.

bill requires the Department of Transportation (DOT) to issue a rule that requires all new motor vehicles to have devices that can access AM broadcast stations installed as standard equipment. (AM broadcast stations are often used to deliver emergency alerts and news and entertainment programming; some newer vehicles do not include AM equipment.) Until the law passes, Congressman Gottenheimer (NJ) is calling on the National Highway Traffic Safety Administration (NTSB) to require automakers to label vehicles without AM receivers as "unsafe in certain emergencies." United Nations (UN)

The UN's UNESCO agency is promoting the "education, science, culture, communication and information to foster mutual understanding." The agency designated February 13, as "World Radio Day," by releasing a broadcast-quality public service announcement, calling broadcast radio a "vital lifeline" and encouraging the "protection of emergency radio frequencies for the public dissemination of vital information." Smell MyCity is a smartphone app designed to crowdsource reports of pollution odors travelling through our cities. All smell reports submitted through the app are visible on our map, and this information is publicly available through our website (smellmycity.org). 1. **AirNow.** AirNow is a one-stop source for air quality data. The Screen site highlights air quality in your local area and provides air quality information at state, national, and world views via an interactive map. - 3. **Fifth Ward/Kashmere Gardens UPRR Update**On February 27, 2023, EPA announced an Administrative Settlement Agreement and Order on Consent with UPRR. The consent order compels UPRR to investigate and evaluate potential contamination in and around the former wood preserving facility in the Greater Fifth Ward area of Houston, Texas. UPRR will conduct the investigation and evaluation and EPA will oversee their work. The field work is expected to begin in early Spring 2023. (https://www.epa.gov/up-houston-fifth-ward)
- 4. **KMCO Chemical Facility.** U.S. Chemical Safety and Hazard Investigation Board Fatal Equipment Rupture, Explosion, and Fire at the KMCO Chemical Facility, Crosby, Texas | Incident Date: April 2, 2019 | No. 2019-02-I-TX Investigation Report Published: December 2023 is now available. The three primary safety issues were SAFETY ISSUES: 1) Emergency Response, 2) Remote Isolation, and 3) Hazard Evaluation..."KMCO filed for Chapter 7 Bankruptcy (liquidation) in May 2020, and the facility was sold to Altivia Oxide Chemicals, LLC ("Altivia"). In July 2020, Altivia informed the CSB that it planned to dismantle KMCO's sulfurized isobutylene equipment involved in the incident as part of the company's efforts to install and operate new oxide reaction equipment at the Crosby, Texas, facility. - 5. **Tier2 Submit and CAMEO Data Manager Softwar**e Updates were released in early 2024. The official versions of Tier2 Submit 2023 and CAMEO Data Manager 4.3.0 for report year 2023 are now available on the EPA website.

Department of Labor (DOL)

DOL seeks to expand and establish protections for Emergency Response Workers. **OSHA** will publish a proposal in January 2024 to update an existing standard and expand safety and health protections for emergency responders, including firefighters, emergency medical



service providers and technical search and rescue workers. OSHA will issue a Notice of Proposed Rulemaking to modernize the agency's "Fire Brigades" standard as its protections for a narrow set of industrial and private firefighters have become outdated.
