SPECIAL PRESENTATION: SHSU Institute of Homeland Security

Reyna Loosmore, Program Manager for Water/Wastewater Critical Infrastructure Sector. Ms. Loosmore joined the Institute in 2023 focusing on security, resiliency, and continuity of the Water/Wastewater Critical Infrastructure Sector. Prior to joining the Institute for Homeland Security, Ms. Loosmore served in the positions of Private Sector: Environmental Scientist – conducting inspections of landfills and transfer stations in Texas and Mississippi; Public Sector: Biosafety and Chemical Manager Sam Houston State University Environmental Health and Safety Department, and Public Sector: Industrial and Hazardous Waste Investigator and later Environmental Crimes Investigator (covering all three media: air, water, and waste) for Texas Commission on Environmental Quality (TCEQ). Ms. Loosmore holds a Bachelor of Science in Geology from Sam Houston State University and a Master of Science in Environmental Management from the University of Houston Clear Lake.

STATE UPDATES

Texas Commission on Environmental Quality (TCEQ)

- 1. There are no pending proposals at this time.
- 2. **Grants for Alternative Fuel Vehicles and Conversion Systems.** The Light-Duty Motor Vehicle Purchase or Lease Incentive Program provides grants for purchasing or leasing new vehicles or conversion systems, powered by alternative fuel. Applications accepted for grants through March 22, 2024. (https://www.tceg.texas.gov/airquality/terp/ld.html)
- 3. **Grants for Hydrogen Infrastructure, Vehicles, and Equipment.** The Texas Hydrogen Infrastructure, Vehicle, and Equipment Grant Program (THIVE) provides grants in eligible counties for hydrogen vehicles, equipment, and refueling infrastructure. Accepting applications for grants through February 27, 2024. This is a competitive program based on criteria outlined in the Request for Grant Applications document. FEDERAL

Environmental Protection Agency (EPA)

- 1. Dec. 2, 2023, the EPA announced at COP28 in Dubai, United Arab Emirates (UAE) a final rule used to reduce methane and other harmful air pollutants from the oil and natural gas industry, promote the use of cutting-edge methane detection technologies, and deliver significant economic and public health benefits.
- 2. Texas Southern University (TSU) has been selected to serve as Regional Grantmaker that will receive \$50,000,000 under EPA's Environmental Justice Thriving Communities Grantmaking program. This program, which will make it easier for small community-based organizations to access federal environmental justice funding, responds to community feedback about the need to reduce barriers to federal funds



and improve the efficiency of the awards process to ensure communities that have long faced underinvestment can access the benefits of the investment. Communities will be able to apply to TSU Bullard Center for Environmental and Climate Justice for a subgrant to fund a range of different environmental project activities, including small local clean ups, local emergency preparedness and disaster resiliency programs, environmental workforce development programs for local jobs reducing greenhouse gas emissions, fence line air quality and asthma related projects, healthy homes programs, and projects addressing illegal dumping.

- 4. Public Notice: Proposal to Reclassify the ... Houston-Galveston-Brazoria Nonattainment Areas from Moderate to Serious for the 2015 Ozone Standard. The Clean Air Act requires that EPA grant this request to move to a higher classification, which provides additional time for nonattainment areas to attain the 2015 ozone standard and also requires the state to implement more stringent measures in these communities. The proposed action also provides technical requirements and a range of deadlines for the state of Texas to submit changes to the clean air plans for each area. Submit your comments on Docket ID No. EPA-R06-OAR-2023-0536 to the Federal eRulemaking Portal at Regulations.gov. The **Environmental Justice toolkit** for lead paint enforcement program have been released to use during all stages of environmental enforcement and compliance monitoring activities designed to eliminate harmful exposures to lead paint in housing. - 6. **Fifth Ward/Kashmere Gardens UPRR Update**EPA is focusing its Superfund Authority (CERCLA) on the source of contamination at the former creosote operation (aka the Houston Wood Preserving Works site). There is existing sampling data which confirms there is creosote related contamination on and near the former creosote operation. There is a ground water plume located on the former creosote site and to the north and west. Agencies involved: US EPA, TCEQ, Department of State Health Services (DSHS), City of Houston, and Harris County.
