## STATE UPDATES

# Texas Commission on Environmental Quality (TCEQ)

- 1. TCEQ is accepting applications under the Governmental Alternative Fuel Fleet (GAFF) Program. The GAFF Program will be providing an estimated \$3.9 million in grant funding to help government entities with 15 motor vehicles or more purchase or lease new vehicles that operate primarily on compressed natural gas, liquified natural gas, liquified petroleum gas (propane), hydrogen fuel cells, or electricity. - 2. Approval 11/29/2023: Proposed Rulemaking Chapter 115, Control of Air Pollution from Volatile Organic Compounds VOC Rule Revisions for Ozone Nonattainment Areas Rule Project No. 2023-116-115-Al. The rule project would revise Chapter 115 to implement rules necessary to meet federal SIP requirements in the Dallas-Fort Worth and Houston-Galveston-Brazoria 2008 ozone NAAOS severe nonattainment areas and, as a result of merging 2023-113-115-AI with this project, the Bexar County 2015 ozone NAAQS moderate nonattainment area. Effective 11/7/2022, the EPA reclassified Bexar County, nine counties in the Dallas-Fort Worth (DFW) area and six counties in the Houston-Galveston-Brazoria (HGB) area (Brazoria, Chambers, Fort Bend, Galveston, Harris, and Montgomery Counties) from marginal to moderate for the 2015 eight-hour ozone National Ambient Air Quality Standard (NAAQS) (87 Federal Register (FR) 60897). The attainment date for the ... HGB 2015 ozone NAAQS moderate nonattainment areas is 8/3/2024. Also, effective 11/7/2022, EPA reclassified ... eight counties in the HGB area (Brazoria, Chambers, Fort Bend, Galveston, Harris, Liberty, Montgomery, and Waller Counties) from serious to severe for the 2008 eight-hour ozone NAAQS (87 FR 60926). The attainment date for the ... HGB 2008 ozone NAAQS severe nonattainment areas is 7/20/2027. Nonattainment areas classified as moderate and above are required to meet the mandates of the federal Clean Air Act (FCAA) under §172(c)(1) and §182(b)(2). FCAA, §172(c)(1) requires that the State Implementation Plan (SIP) incorporate all reasonably available control measures (RACM), including reasonably available control technology (RACT), as expeditiously as practicable. Approval 11/29/2023: Proposed Rulemaking Chapter 117, Control of Air Pollution from Nitrogen Compounds NOX Rule Revisions for DFW and HGB Ozone Nonattainment Areas Rule Project No. 2023-117-117-Al. Effective 11/7/2022, the EPA reclassified ... six counties in the Houston-Galveston-Brazoria (HGB) area (Brazoria, Chambers, Fort Bend, Galveston, Harris, and Montgomery Counties) from marginal to moderate for the 2015 eighthour ozone National Ambient Air Quality Standard (NAAQS) (87 Federal Register 60897). The attainment date for the ... HGB 2015 ozone NAAQS moderate nonattainment areas is 8/3/2024. Also, effective 11/7/2022, EPA reclassified ... eight counties in the HGB area (Brazoria, Chambers, Fort Bend, Galveston, Harris, Liberty, Montgomery, and Waller Counties) from serious to severe for the 2008 eight-hour ozone NAAQS (87 FR 60926). The attainment date for the DFW and HGB 2008 ozone NAAQS severe nonattainment areas is 7/20/2027. Nonattainment areas classified as moderate and above are required to meet the mandates of the federal Clean Air Act (FCAA) under §172(c)(1) and §182(b)(2) and (f). FCAA, §172(c)(1) requires that the State Implementation Plan (SIP) incorporate all reasonably available control measures (RACM), including reasonably available control technology (RACT), as expeditiously as practicable. # **Environmental Protection Agency (EPA)**

- 1. **Celebrating Native American Heritage Month**, honoring the culture, knowledge, and countless contributions of Indigenous people.
- 2. **The Inflation Reduction Act** provided EPA with \$50 million to help address indoor air quality issues and reduce greenhouse gas emissions at K-12 schools in low-income, disadvantaged, and Tribal communities. (https://www.epa.gov/iaq-schools)
- 3. **LEPC requests MSDS** for substances not defined as hazardous chemicals. The LEPC can only request the MSDS for a substance that is defined as a hazardous chemical under 40 CFR 370.66. Since a substance used in a research laboratory under the direct supervision of a technically qualified individual is not a hazardous chemical as defined by 40 CFR 370.66, the facility does not need to submit the MSDS for this substance to the LEPC. - **4. Video** addressing common chemical management and safety issues at warehouses and distribution facilities.
- 5. Advance Notice of Proposed Rulemaking for Reporting Air Releases of Hazardous Substances from Animal Waste at Farms under EPCRA. EPA is seeking information on how to promote compliance and accuracy in reporting, how to streamline reporting requirements, a potential small farm exemption, and user needs for a reporting instrument, including identifying when reporting would be required.

- 4. FEMA Releases Business Emergency Operations Center Guide for Private-Public Partnerships for Public Comment
- 5. USDOT Proposes Updates to Gas Distribution Pipeline Regulations, Bolstering Safety Requirements and Strengthening Community Protections. The U.S. Department of Transportation's Pipeline and Hazardous Materials Safety Administration (PHMSA) announced a Notice of Proposed Rulemaking (NPRM) to strengthen safety requirements for millions of miles of gas distribution pipelines. These proposed changes aim to improve safety and mitigate risk through the improvement of emergency response plans, integrity management plans, operation manuals, and more. This proposal comes after the tragic Merrimack Valley incident, which injured dozens and resulted in one fatality. (


