




Safety Spot: Winter Worksite Awareness

Winter weather brings unique hazards to the jobsite that require extra planning and attention. Snow, ice, freezing temperatures, and reduced daylight all increase the risk of injuries if not managed properly.

Key Winter Safety Reminders:

- **Prevent slips and falls:** Ice and snow should be removed promptly from walkways, stairs, ladders, and equipment access points. Use ice melt or sand where needed and wear slip-resistant footwear.
- **Dress for the conditions:** Wear layered clothing that allows movement while keeping you warm. Gloves should provide both insulation and grip. Cold hands reduce dexterity and increase injury risk.
- **Watch daylight hours:** Shorter days mean more work in low-light conditions. Ensure proper lighting is in place and wear high-visibility clothing at all times.
- **Equipment considerations:** Cold temperatures can affect equipment performance. Inspect tools, cords, and machinery regularly and allow equipment to warm up as recommended.
- **Look out for each other:** Cold stress and fatigue can sneak up quickly. Take breaks to warm up, stay hydrated, and speak up if you notice unsafe conditions.

New Year Reminder:

As we start a new year, let's recommit to working safely every day. Slowing down, planning ahead, and watching out for one another helps ensure everyone goes home safe.


