Tobin Lake AYA Tournament



Tournament to be held on **Saturday, June 8th, 2024**. In the event of inclement weather, the alternate date will be Sunday, June 9th, 2024. Cancellation due to weather conditions are at the discretion of the organizing committee and will result in the cancellation of the tournament and all prizes will be awarded by draw. In order to be eligible for prizes, anglers must be present at the draw.

Eligibility:

Three (3) people **max** per team – Each team will consist of **one adult** and **up to two youth** age 17 and under.

Requirements:

1. All anglers 16 years of age or older who participate, must possess a valid Saskatchewan angling license (excluding Saskatchewan residents 65 years of age or older, First Nations or Métis with Treaty or Aboriginal rights recognized in Saskatchewan).
2. Each contestant will be required to have a Canadian approved floatation device and **everyone must wear it at all times when in the boat**. Tether kill switch strap must be worn at all times of travel above idle speed.
3. All contestants are required to observe Canadian rules and regulations.
4. Boat Operator must have a valid Pleasure Craft Operator Card.
5. All teams must use **live wells**. These live wells must be aerated to retain live fish.
6. Participants **must** possess a valid **Resort Village of Tobin Lake Facility Pass**.
 - Please ensure you obtain one **prior** to launch time to guarantee your vehicle is not ticketed.
 - **Passes & Fishing Licenses** are available at The Rusty Hook store as you come into the village.
 - **Facility Passes** are available at the Resort Village Office from Monday to Friday from 9:00 am to 4:30 pm. as well as at participating local businesses.

Starting & Fishing Hours:

1. Fishing **starts** at **9:00 am** and ends at **4:00 pm**.
2. Launch at **9:00 am** – using a numerical trickle start. The horn will sound to signal launch time.
3. Team Registration, Boat Number sticker, rules sheet and snack packs will be handed out prior to launch near the Community Hall starting at **8:00 am**. **You must stop and register prior to heading to the launch**.
4. For those not launching from main dock, you must go to the main dock to register and have your boat inspected prior to launch time. Prior arrangements must be made to ensure your registration package is available at the main dock prior to boat inspection by emailing tobinlakeaya@gmail.com.
5. Live well and boat inspection will take place at the main dock as you are launching.
*For those of you needing assistance with truck/parking, we will have volunteers available to help out. Your keys will be tagged by boat number so that we can also help when you return.
6. You must **check IN** at the main dock when you return to the launch (**or prior to docking if you are returning to home dock**) as we want to ensure that all teams have arrived back safely at the end of fishing.
7. Seven (**7**) hours of fishing time is allowed, however, if any of participants are not able do a full day, they can be returned to main dock provided they have someone there to meet them when dropped off.
8. In order to be eligible for prizes, each team must return and report to main dock **no later than 4:00 pm**.

Fishing:

1. Only walleye/sauger/saugeye will be measured. All 'non-eligible' fish species caught during the event must be immediately released.
2. **IMPORTANT: Only 5 fish may be presented for measurement for the daily total.**
3. **No more than three (3) fish may be in your live well at one time and culling is allowed.**
4. Fish **under 55 cm or over 86 cm** can be measured. Only 1 fish over 86 cm may be presented for measurement. If a fish is deemed to be in the protected zone between 55 cm to 86 cm and presented for measurement, it will be marked as 0 cm and count as a big fish.

Note: presenting a protected zone fish is a violation and could include a fine from the Min. of Environment CO.

5. Any stressed fish presented for measurement will be penalized 25% of length.
6. Any dead fish will be counted as your big fish for 0 cm.
7. Each fisherman will be allowed to have only 1 line in the water at a time. Spare rods/equip may be carried in the boat.
8. All measurements will be pinch tail measurements and will be measured belly to belly, with the nose of the fish to the left side of the ruler.
9. Tobin Lake is a "BARBLESS HOOKS ONLY" lake.
10. Tournament boundaries are between the mouth of the River and E.B. Campbell Dam. Refer to your map of Tobin Lake.

Prizes:

1. All prizes will be based on the **total measurement of five (5)** legal fish per team.
2. Prizes will be awarded in order of the teams combined length overall. In the case of a tie, the team's longest fish will determine the winner.
3. All youth anglers will have an opportunity to choose from the many sponsored prizes available.
4. Supper will be served at 5:00 pm at the Community Hall with Awards Presentation to follow.

"Spirit of the Rule":

1. All rules have 'loopholes'. It is the intention of the organizers to provide an honest, sportsperson derby. In the interest of good sportsmanship contestants are reminded the "Spirit of the Rule" will prevail in all judgement cases.
2. Any disputes will be settled by the Event Director(s).
3. All entries not necessarily accepted and a 20% overbook may be accepted. There will be no refunds once an entry has been accepted.
4. Any team not abiding by the Saskatchewan Angling Regulations will be disqualified.

Waiver:

Promoters, organizers and agents are not responsible for death, injury, damage liability, theft, fire or loss to any entrants. Each entrant, upon signing an entry form will in effect be signing a waiver.

3. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS for myself and youth anglers that I am responsible for, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and
4. I willingly agree to comply with the applicable rules and regulations for participation for myself and youth anglers that I am responsible for. If, however, I or the youth anglers that I am responsible for observe any unusual significant hazard during my presence or participation, I will remove myself and the youth anglers I am responsible for from participation and bring such to the attention of the nearest official immediately; and
5. All participants are required to act with due care for their own safety and the safety of others while participating in the tournament and any related activities. Angler & Young Angler Fishing Tournaments Inc. (AYA) and the Resort Village of Tobin Lake (RVTL) does not assume any liability or responsibility for any participant. AYA and RVTL will not be responsible for any personal injury to participants or for any loss of or damage to the personal property of participants, while participating in the tournament.
