# A BYLAW OF THE RESORT VILLAGE OF TOBIN LAKE IN THE PROVINCE OF SASKATCHEWAN TO PROVIDE FOR A MINIMUM TAX

The Council of The Resort Village of Tobin Lake in the Province of Saskatchewan enacts as follows:

1. This bylaw shall be known as the "Minimum Tax Bylaw".

2. A minimum tax shall apply to the types and classifications of property included in the table below:

Commercial & Industrial	.0175 dollars per square foot	

- 3. Where a property is classified within more than one property classification by the Saskatchewan Assessment Management Agency, the minimum tax calculation shall be the higher of the applicable classes.
- 4. This bylaw shall come into effect on the final passing thereof.

#### BASE TAX BYLAW

## A BYLAW OF THE RESORT VILLAGE OF TOBIN LAKE IN THE PROVINCE OF SASKATCHEWAN TO PROVIDE FOR A BASE TAX

The Council of The Resort Village of Tobin Lake, in the Province of Saskatchewan, enacts as follows:

1. This bylaw shall be known as the "Base Tax Bylaw".

2. A base tax shall apply to the types and classifications of property included in the table below:

Property Class	Type of Property		
	Land	Improvements	Land & Improvements
Residential	\$850.00	\$0.00	\$850.00
Agricultural	\$850.00	\$0.00	\$850.00
Commercial	\$100.00	\$0.00	\$100.00

3. Where a property is classified within more than one property classification by the Saskatchewan Assessment Management Agency, the base tax calculation shall be the higher of the applicable classes.

4. Environmental Levy of \$100 from each base tax to be dedicated to the water treatment

plant expansion.

5. Bylaw 3/2014 passed on June 19, 2014 is hereby repealed.

## RESORT VILLAGE OF TOBIN LAKE BYLAW NO. 3/2015 MILL RATE FACTOR BYLAW

## A BYLAW OF THE RESORT VILLAGE OF TOBIN LAKE IN THE PROVINCE OF SASKATCHEWAN TO ESTABLISH MILL RATE FACTORS

The Council of The Resort Village of Tobin Lake, in the Province of Saskatchewan, enacts as follows:

1. This bylaw shall be known as the "Mill Rate Factor Bylaw".

2. The following mill rate factors shall be applied to the uniform mill rate levied against residential and agricultural: taxable land, improvements, land and improvements for municipal purposes:

Classification	Mill Rate Factor
Residential	0.81
Agricultural	0.81

3. The following mill rate factors shall be applied to the uniform mill rate levied against commercial improvements for municipal purposes:

Classification	Mill Rate Factor
Commercial	1.94

4. Bylaw 2/2014 passed on June 19, 2014 is hereby repealed.
