COACHING AGREEMENT

<u>The Coaching Engagement</u>: Our coaching engagement can be customized to meet your individual needs. Our sessions will be held by Phone, Skype, FaceTime, WhatsApp, or Facebook Messenger Video. At the time of our appointment, please call me on (267) 254-3463, using any of these methods.

Fees & Payment Policies:

- Various Package Options & Rates are offered. Please scroll down to view them. Some people prefer to have weekly sessions, while others do bi-weekly. Also, the length of the coaching engagement can be 1 month, 3 months, or 6 months and beyond. Longer coaching engagements will show lower rates/session (more savings).
- You'll notice on the Package Options & Rates that if payment is made in full and upfront on any of the package options, there will be an additional discount.
- The following payment methods are accepted: PayPal, Venmo and Zelle. -ONGOING COACHING:

- Unless written notice is received at least 3 days prior to the end of the coaching engagement, the initial coaching engagement will become an ongoing coaching engagement, and the investment will remain the same as above for an additional engagement.
- If ongoing coaching is not renewed, individual sessions may be purchased at any time for \$150 each
- Sessions must be used for the months they are purchased. They may not be saved.

<u>Keeping Appointments</u>: Coaching is a commitment. I encourage you to keep your regularly scheduled appointments, as the results of our work together are cumulative. <u>Confidentiality:</u> Your identity as a coaching client and all communications between us will be held as strictly confidential, to the extent permitted by law, unless you give me express permission to disclose specific information. While the coach-client relationship is not privileged and I may be required to disclose confidential information in a legal proceeding, it is highly unlikely that this will occur. If there is evidence

that you are a potential danger to yourself or another, or that you disclose illegal activity, I am ethically bound to report it to the appropriate authority. In such a case, I will discuss it with you before taking such action.

Release of Information: As a professional coach, I engage in training and continuing education to pursue and/or maintain credentials with the International Coach Federation. That process requires that I provide the names and contact information of clients for possible verification by the ICF. By initialing this portion of the agreement, you agree (or refuse) to have only your name, contact information and start and end dates of coaching shared with ICF staff members and/or other parties involved in this process, for the sole purpose of verifying the coaching relationship.
