Old Business

TRL Boat Launch Maintenance - Broberg recounted how well it went, pointed out that he ordered larger 4" rock in an effort to slow down the erosion, and Thanked Fred Haak for the nice pictures of the process, and extended a special Thank you to Doug TRL equipment operator. It was pointed out that the Wolf Island landing could use the fresh rock raked out a bit.

Moose Lake Club landing parking - Broberg recalled the issue of parking patterns at the landing that make it difficult to launch or pull out a water craft. He proposed a drawing with measurements that would facilitate better movement. After a lengthy discussion, it was decided to table further action until Koehler and Broberg were able to share our plans with Dave Sanders and his crew. Onarheim suggested we also share our plans with adjacent land owners. It was pointed out in the discussion that this being a TRL boat landing, MLIA will not police the landing, that will fall to the sheriff's department.

Little Moose Shelter renovation - Koehler informed the board that the US Forest Service has approved our plans, so we have to decide whether to complete this project this winter or wait till next spring, stay tuned.

Osprey Nesting Platforms - Koehler reported that the US Fish &

Wildlife Service is in favor of the project, we have to decide if we want one or two platforms, and if we can use the abandoned one by improving it. Wiltrout will get pictures of the existing one for next meeting discussion.

Moose Lake Club Boat Landing Informational Signage -Onarheim reported that he has the materials and will complete the project by our next meeting.

Loon Watch - Koehler said that we now have a dual working for the loons, Sarah Unz & Dina Byrnes, and Sarah will be at our February meeting to discuss how MLIA can help them with nesting boxes, and other ideas.
