locate her current placement. Faulkner contacted me at a later time and informed me of Cindy [REDACTED] current address and foster parents.

I conducted a records check on Cindy [REDACTED] and located a report that was accomplished in November 1998 (98-43389). In this report, Cindy [REDACTED] reported she was touched by Greg Dunn who was her previous foster parent. Cindy [REDACTED] had already moved out of Greg Dunn's home and was living with a new foster family when she reported this. Cindy [REDACTED] stated that Greg Dunn licked her [REDACTED] one night while inside her bedroom. Greg Dunn told Cindy [REDACTED] that it was a secret and not to tell anyone. No criminal charges were filed as a result of this incident. A copy of this report is attached.

I also located another report from December of 1998 (98-48280) where allegations of physical/sexual abuse were going on in a different foster home where Cindy [REDACTED] was living. This was the home Cindy [REDACTED] was moved to after leaving the foster of home of Greg Dunn. In this incident, there were other foster children alleging being touched by the foster father. Cindy [REDACTED] was interviewed and denied that she was being touched by this foster father. A copy of this report is attached.

On 10/30/09 Cindy [REDACTED] (18) came to the Bakersfield Police Department for an interview. I began by asking [REDACTED] several questions regarding her identity, such as her name, birth date, address, and school.

I asked [REDACTED] if she knew why she was here and she told me her mother told her I was going to ask her about some guy but she did not know who it was. [REDACTED] also said she was told it was regarding a home she was living in before moving to Josephina [REDACTED] home. [REDACTED] told me that she did not remember anything about the home. I asked [REDACTED] if she remembered anyone else who lived in the home with her such as a brother or sister. [REDACTED] told me she recalled there were two boys who lived in the home and thought one of them was named Paul. [REDACTED] told me that she believed they were foster children.

I asked [REDACTED] if she remembers the first day she arrived at Josephina [REDACTED] home and she told me she did and remembered she was 7 years old. I asked [REDACTED] what she remembered about the people she was living with right before moving to Josephina [REDACTED] home. [REDACTED] told me she remembered the name of one of the people as "Greg". I asked [REDACTED] what she remembered about Greg and she told me she thought he was "white". I asked [REDACTED] what she remembered about his wife and she told me she did not know.

I asked [REDACTED] what else her mother told her I was going to ask her about and she said I was going to ask her about that family. I asked [REDACTED] if her mother said anything more specific and she told me no.

I asked [REDACTED] what she remembered about Greg and she told me "nothing really". I then explained to [REDACTED] that my current job was to investigate all types of child abuse and that I was currently conducting an

investigation. I told [REDACTED] that it may or may not involve this family that she had previously lived with. [REDACTED] then asked me if someone had already talked to her about this and I told her that she had been talked to.

I told [REDACTED] that I wanted to ask her about this home she used to live in and anything that happened when she lived there. I told her that it was very important to try and recall anything that might have happened. [REDACTED] told me it was probably a repressed memory.

[REDACTED] told me that she recalled having her appendix taken out and she had to wear a diaper. [REDACTED] told me she thought she was younger than 7 when this happened.

I told [REDACTED] I had a report from 1999 where she said something happened, however, I needed her to recall on her own what it was that happened. I told [REDACTED] I did not want to tell her what was in the report and I needed her to try and recall anything that happened.

I asked [REDACTED] what happened to the children in the home if they got in trouble and she told me she thought they were made to stay in their room. I asked [REDACTED] if there was any discipline that she thought was inappropriate and she told me she did not see anything.

I asked [REDACTED] if she remembered anything about Greg and anything he could have done inappropriate to her. [REDACTED] told me that she did not remember and did not know if Greg was White or Mexican. I told [REDACTED] that 10 years ago she reported that Greg did something to her and asked her if she could remember what that was. [REDACTED] told me she could not remember. I asked [REDACTED] if she thought about it for a day or so if she could remember. [REDACTED] told me that was possible.

I again told [REDACTED] that 10 years ago she reported that something happened. [REDACTED] told me that she was sure it happened because she would not lie. [REDACTED] told me that she thought it had something to do with diapers. I told [REDACTED] I needed her to recall that incident on her own with out me telling her what was reported.

[REDACTED] then told me she believed she knew and then told me that one time Greg licked her [REDACTED] when he changed her diaper. [REDACTED] told me that Greg sent her to her room for no good reason and it happened in the room. [REDACTED] said no one else was around to see it. [REDACTED] told me she shared a room with another little boy, however, he was not at home at the time. I asked [REDACTED] if she remembered if Greg said anything while this was going on. [REDACTED] stated that Greg told her not to tell anyone.

[REDACTED] told me she was laying on the bed and Greg was standing. I asked [REDACTED] how her private area got exposed and she told me Greg took her diaper off. I asked [REDACTED] what happened with the diaper and she stated he hung it on a bicycle handle. I asked [REDACTED] if she recalled it lasting a long time and she said it was really quick. I asked [REDACTED] what happened after that and she stated she believed she told the mother. [REDACTED] told me that she only recalled this happening one time.

I asked [REDACTED] how she liked Greg at the time and she said she did not really like him. I asked [REDACTED] if she remembered Greg's wife and she said she did not. [REDACTED] told me she was in too many foster homes and could have Greg mixed up with someone else. I asked [REDACTED] if she saw this
