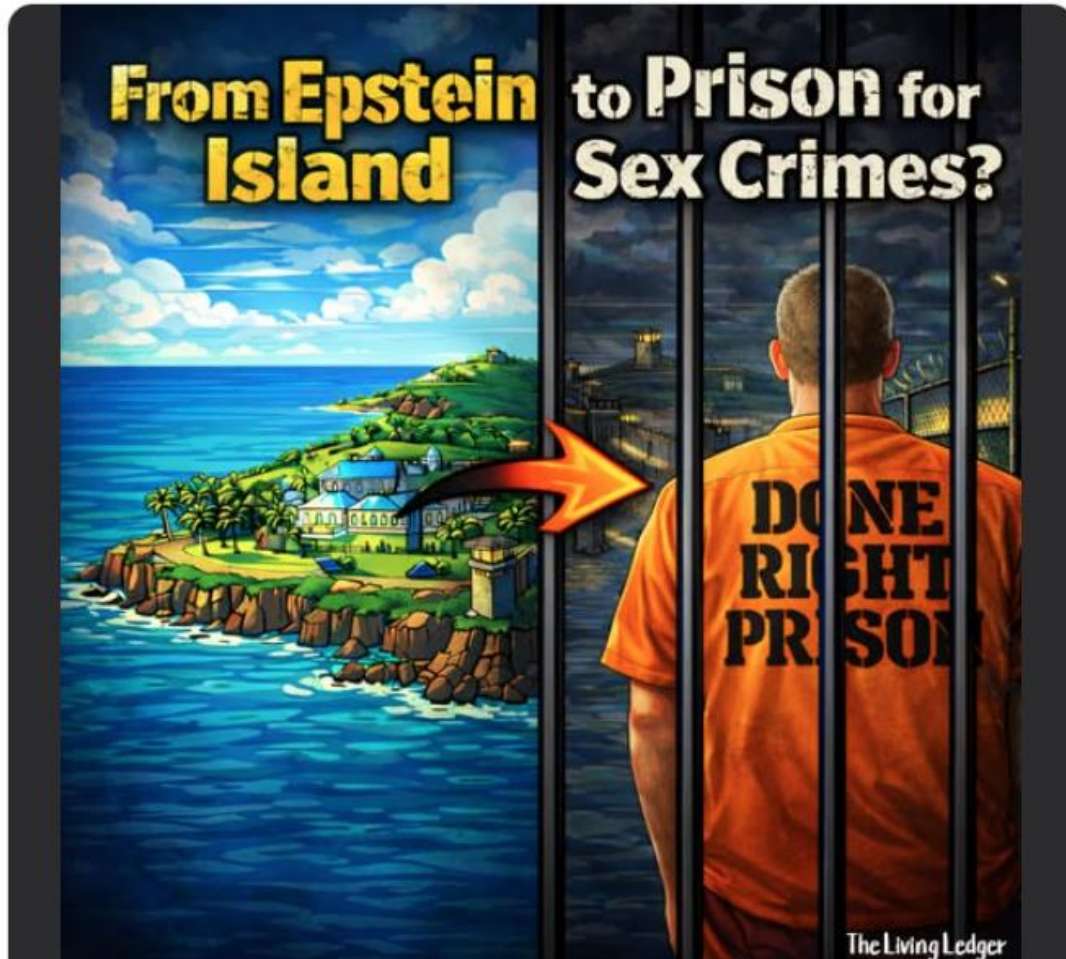

I'm still really baffled by the lack of discussion of Greg Dunn as a sexual predator. There is a signed Order in California, where he waived his rights to challenge the charges, which establishes the conditions and restrictions regarding his access to children. He and his wife then left California and moved here to our community, where he is violating the terms of that Order over and over again.

It is obvious he is a sexual predator and he has no business living next to schools, posting updated videos of the playground when it opened, attending high school games where his daughter was competing and taking pictures. What's even more disappointing is the fact that his wife also signed the order and is known about this. This stipulation and Order was used instead of a criminal trial, since often it is very difficult to get children to testify in court or in a deposition. This stipulation and Order by a state agency is legal, binding, and was the best way to pursue this issue at the time. While he may not have served time in jail, the terms of the Order are basically the same restrictions that a court would have applied. If he wasn't guilty, why did he waive his rights to a hearing and contest the charges?? He didn't and neither did his wife.

People talk about how great Waldport is, but shielding a pedophile on the Council makes this community look pretty bad. So come on Waldport, force Dunn to resign immediately and boycott his business.
