Thank you for the phone call and email inquiring about a business called Seashore Family Literacy owned by Sentila McKinley. I was unaware about this business or the location(s).

This business is noted on the web as located at 125 NW Spruce Street in Waldport, Oregon 97394
BUT the website states they are at 265 N. Bay Street in Waldport, Oregon (which is the old school) Monday through Friday starting June 21, 2021 from 1200-1400 hours
The phone number is 541.563.7323
Mailing address is PO Box 266 Waldport, Or. 97394
The web stated the location is dedicated to helping children, adults and families improve on reading, writing, math, computer and communication skills.
The web site states there is free lunch for kids and 62 K-12 Students received academic after school and summer tutoring.

Al - Do you know about this business or if they were approved to occupy the building at 265 N. Bay Street in Waldport?
I see it is a school building so it doesn't sound like a change of occupancy but I wasn't sure of the condition of the building and if it is occupiable.

Dann - Could you help us out and let us know if there a business license with the City of Waldport for this business and the address the business license is for?

Early Learning Division stated they are not a licensed child education/care facility and they are taking it down as a compliant and will make a visit/ investigate for further information.

Heide- You were telling me there was about 20 youths in and out of the buildings that you seen, but you didn't think they were sleeping at the facility, it was a daytime use.
Do you know about the age group of the children?
And for information to the Building Official and health Inspector, you received a complaint of food service and private child education without a license, non-working bathrooms or water?

Chief- I think both of these locations are worthy of a fire inspection, I just would like to know a little more information about the business, history, authorization prior to jumping in for the fire inspection.
