



## **Florida Utilities Coordinating Committee Nomination for Malcolm Yancey Award**

The Malcom Yancey award is presented every two years at the Summer Awards Banquet. This award recognizes an individual's commitment to coordination and to the FUCC. Nominees do not need to be utility coordinators but demonstrate a commitment to the organization and coordination. Think of this award as a "Lifetime Service Award". One honor that accompanies this award is free registration for all future meetings.

### **Malcom Yancey Award History & Criteria**

Malcolm Yancey was a Civil Engineer that started with the State Road Department in 1919 as an Inspector. He earned his BS in Civil Engineering while attending the University of Florida, and he rose through the ranks to District Engineer. Then he served 12 years as City Manager of Tallahassee, before returning to the State Road Department as Engineer Right-of-Way. He retired with 48 (forty-eight) years of public service. Mr. Malcolm Yancey was very active in the American Right-of-Way Association, as well as the Florida Utility Coordinating Committee. He was one of the men responsible for the close cooperation between the utilities and the Department of Transportation that exists today.

The by-laws of the Florida Utilities Coordinating Committee authorize this award and states this is the most prestigious award presented by the Florida Utilities Coordinating Committee, and is subject to the following:

1. The recipient must receive the approval of 2/3rds of the participating past Malcom Yancey and John Farkas award winners.
2. The recipient must have been an active member of the Florida Utilities Coordinating Committee for at least five years.
3. Must have provided outstanding leadership during the previous years and the year under consideration.
4. This award may not be awarded more than once during a two-year period.
