Don't Let Your Faith Be Eclipsed

In just a few days we will be experiencing a total eclipse of the sun. Being so close to Easter this year has brought back the question of could there have been an eclipse in Jerusalem on Good Friday when Jesus was crucified. Could that explain the darkness that fell over the land? Here is a scientific answer:



"Astronomically, Passover occurs when there is a full moon, meaning when the moon is on the opposite side of the Earth from the sun and thus is fully illuminated by the sun's rays. A partial or total solar eclipse, meanwhile, occurs only with a new moon, defined as the phase when the moon is passing between the Earth and the sun, which is why it blocks the sun's rays.

"While most attempts to work out dates of historical events based on astronomical events can be problematical, this one is easy!" Brother Guy Consolmagno, a research astronomer who is also director of the Vatican Observatory, said, "The Crucifixion took place on Passover, which is the first full moon of spring. You need a new moon, not a full moon, for a solar eclipse. Exactly the wrong phase of the moon.""

So, the simple answer is, "No eclipse." Besides that, darkness only lasts for a few minutes, not three hours. So why do people want to speculate that there was an eclipse? There are two fairly simple answers to that as well.

First, some Christians don't really believe in miracles and think that there are logical explanations and events that got passed off as miracles on people who didn't know any different.

The second reason is that there are people who want to discredit the Bible and would seek to have people put their trust in science or to at least get them stp believing in what they consider myths and legends.



Why go through all the trouble to deny the darkness at Jesus' crucifixion? The reason is the same as trying to say He didn't rise from the dead. Now, the Apostle Paul said this, (1 Corinthians 15:14), "And if Christ has not been raised, then our preaching is in vain and your faith is in vain."

So why does this matter to an unbeliever? Humanists want to believe they are in control and having to believe the only way to heaven is through Jesus Christ is unacceptable. If Christianity cannot be discredited then foundation of it would be true and therefore heaven and hell would be real, also. To them, much like Adam and Eve, the "fruit" they are eating is pleasant to them and they don't want to stop. Confessing the need for a Savior and changing one's life to walk in the ways of the Lord is not something they want to do.



So, either miracles can't happen, and Christianity is as make-believe as every other religion, or miracles can happen, and Jesus is the way, the truth, and the life. The disciples knew what they saw, as did hundreds of others before Jesus' ascension into heaven, and they testified to it for the rest of their lives, even when tortured for their faith. Trust the witnesses, not the skeptics. Christ died to save and rose victorious. Hallelujah!

Whose Is It Anyway?

If you have every bought or sold a house, you are acquainted with the concept of a "title search." Before you can sell your house, and before anyone else will feel comfortable putting down the money to buy it, you have to prove that you really own it. So a title company looks through the public records to ensure that you bought it from the person who really owned it, who bought it from the person who really owned it before that, all the way back to the earliest records of your state, including when your state was only a territory or colony of England.



Peak into a preschool classroom during playtime and you'll see a simplified version of this. A child starts playing with a ball, but another child says, "That's mine: I had it first."

You can't understand the Seventh Commandment without understanding this concept of ownership or title. As the Small Catechism puts it:

You shall not steal. What does this mean? We should fear and love God so that we do not take our neighbor's money or possessions, or get them in any dishonest way, but help him to improve and protect his possessions and income.

Your neighbor's possessions are his: you don't have a right to take them. And likewise, your possessions are yours. Ownership and property rights are foundational to any functioning society.

But there is something deeper to know about ownership, and that is the question of who has the title and **ownership to you?** Paul says, "Or do you not know that your body is a temple of the Holy Spirit within you, whom you have from God? You are not your own, for you were bought with a price" (1 Cor. 6:19–20).

If you yourself are owned by God, then of course everything that you own, you really only possess by God's leave: all of it, at bottom, belongs to Him since you belong to Him. For you were bought with the blood of Christ.

This notion is the foundation of all Christian stewardship. It all belongs to God. It should all be used for things that bring honor to His name, blessings to our neighbors and the extension of His kingdom
