PREA 2019 ANNUAL REPORT

PREA Standard 115.388

The Prison Rape Elimination Act (PREA) was established to address sexual abuse and sexual harassment of persons confined to correctional facilities. Standard 115.388 Data Review for Corrective Action of PREA, requires that all public and private institutions that house adult or juvenile offenders review data collected and aggregated on an annual basis in order to assess and enhance the effectiveness of its sexual abuse prevention, detection and response policies, practices and training, including identifying problem areas; taking corrective action on an ongoing basis; and preparing an annual report of its findings and corrective actions for each facility as well as the agency as a whole.

Ware Youth Center Group Home/Treatment Program contracts with the Louisiana Office of Juvenile Justice for 24 Female Group Home beds and 6 female and 6 male Treatment Program beds.

Key Terms and Definitions

NONCONSENSUAL SEXUAL ACTS – unwanted contact with another resident or any contact with staff that involve contact with the penis and the vagina or anus; contact between the mouth and the penis, vagina, or anus; penetration of the anal or vaginal opening of another person by a hand, finger or other object; and rubbing of another persons’ penis or vagina by a hand.

ABUSIVE SEXUAL CONTACT – Unwanted contact with another residents or any contact with staff that involved touching of the residents’ buttocks, thighs, penis, breast or vagina in a sexual way.

SEXUAL HARASSMENT – Repeated and unwelcome sexual advances, requests for sexual favors or verbal comments, gestures, or actions of a derogatory or offensive sexual nature by one resident directed toward another.

STAFF SEXUAL MISCONDUCT – All incidents of willing and unwilling sexual contact with facility staff, and all incidents of sexual activity that involved oral, anal or vaginal penetration.

STAFF SEXUAL HARASSMENT – Repeated verbal comments or gestures of a sexual natures to a resident by a staff member, contractor or volunteer including demeaning references to gender, sexually suggestive derogatory comments about body or clothing, or obscene language or gestures.

2018-2019 Comparison of PREA Allegations

This report includes a comparison of calendar years 2018 and 2019 data on sexual abuse and sexual harassment allegations and provides an assessment of Ware Youth Center Group Home/Treatment Program’s progress in preventing sexual abuse and sexual harassment of its residents. This review included a review of data from all available incident reports, grievances and investigations.

Comparative Analysis

Ware Youth Center Group Home/Treatment Program has seen no major change in the categories of reported PREA allegations from 2018 to 2019. Ware Youth Center Group Home/Treatment Program will continue its efforts in ensuring that residents, staff, volunteers and contractors are educated in the agency's Zero Tolerance policy, as well as the several methods of reporting allegations. Ware Youth Center Group Home/Treatment Program is committed to ensuring continued compliance with PREA Standards as well as the health and safety of the residents in our care. A comparative analysis of 2018 and 2019 data indicates the following:

- There was **no change** in the number of reported allegations of non-consensual resident on resident sexual acts. Both in 2018 and 2019, there were zero reported allegations.
- There was **one** reported incident of resident-on-resident abusive sexual contact in 2018 that was unfounded. In 2019 there were no reported allegations.
- In 2019, there was **one** reported incident of resident-on-resident sexual harassment that was substantiated. In 2018, there were zero reported allegations.
- There was **no change** in the number of reported allegations of staff-on-resident sexual misconduct. Both in 2018 and 2019, there were zero reported allegations.
- There was **no change** in the number of reported allegations of staff-on-resident sexual harassment. Both in 2018 and 2019, there were zero reported allegations.

- All staff received additional PREA training focusing on LGBTQ communication.
